Examination-in-Chief by Ld. Spl. P.P.:

I know C.W.1, C.W.4/P.W.1, C.W.5, C.W.6/P.W.2 and C.W.8, as they are from my village.

I know the Accused present in the Open Court today, as he is from my village.

C.W.1, C.W.6/P.W.2 and myself belong to Hindu (Madar) Caste; C.W.4/P.W.1 belongs to Hindu (Holer) Caste; and Accused belongs to Hindu (Talawar) Caste.

I do not know that, Accused has caused assault upon C.W.1 with the Axe.

I do not know whether Accused is having physical relationship with C.W.4/P.W.1.

C.W.1 happens to be my maternal Uncle.

I do not know that, Accused has abused C.W.1 in filthy language, on taking the name of his Caste.

Sindagi Police have not enquired me in this Case and recorded my Statement.

(The Learned Spl. PP prays to treat this witness hostile. Perused the entire file and the examination-in-chief of this witness. Hence permitted)

Cross Examination by Learned Spl. PP.

It is false to suggest that, Accused and C.W.4/P.W.1 are in physical relationship with eachother; and they are leaving as a husband and wife.

It is false to suggest that, I am aware that, on 16.09.2007 in the evening, when C.W.1 was returning to his residence, on grazing sheeps, when he was near Kanti Stream, Accused No.1 had raised quarrel with C.W.4/P.W.1, he/ Accused was abusing her in filthy language and was using Criminal force against her, leading to outraging her modesty, for which C.W.1 went to rescue C.W.4/P.W.1 from the hands of the Accused, at that time, the Accused abused C.W.1 in filthy language on taking the name of his Caste; and assaulted him with the Axe on his Head, Left hand and Left leg, causing Cut and bleeding injuries to him; thereafter, C.W.1 was admitted to District Hospital, Vijayapura for treatment; for which C.W.1 had lodged the Complaint against the Accused.

It is false to suggest that, I have given Statement before DySP Indi on 17.09.2007 contending that, "ನನ್ನ ಊರು ಬಾದಿಹಾಳ ಪಿ ಎಚ್

----- ಗಾಯ ಪಡಿಸಿದ್ದು ಇರುತ್ತದೆ". For identification, the said Statement is marked as Ex.P.6.

It is false to suggest that, I am deposing falsely in this Case, inorder to help the Accused.

Examination-in-Chief by Ld. Spl. P.P.:

C.W.1 is my husband. I know C.W.4/P.W.1, C.W.5, C.W.7 and 8, as they are from my village.

I know the Accused present in the Open Court today, as he is from my village.

We belongs to Hindu (Madar) Caste; and Accused belongs to Hindu (Talawar) Caste.

About 20 years back, villagers of my village informed me that, a quarrel had taken place inbetween my husband/C.W.1 and the Accused, wherein both of them have assaulted eachother with their respective hands; the said assault has taken place near Kanti Stream in our Budihal PH village.

My husband/C.W.1 had not sustained any injuries in the said quarrel.

My Husband/C.W.1 had died about 5-6 years back, due to prolong illness, as he had received Paralytic Stroke.

I do not know whether Accused has caused assault upon my husband/C.W.1 with the Axe; and my husband/C.W.1 had sustained Cut and Bleeding injuries to his Head, Left Hand and Left Leg.

Sindagi Police have not enquired me in this Case and recorded my Statement.

(The Learned Spl. PP prays to treat this witness hostile. Perused the entire file and the examination-in-chief of this witness. Hence permitted)

Cross Examination by Learned Spl. PP.

It is false to suggest that, Accused and C.W.4/P.W.1 are in physical relationship with eachother; and they are leaving as a husband and wife.

My husband/C.W.1 used to graze Sheeps.

It is false to suggest that, on 16.09.2007 at about 6.00pm when my husband/C.W.1 returned to our residence on grazing Sheeps; he has sustained Cut and Bleeding injuries on his Head, Left Hand and Left Leg; when I enquired my husband/C.W.1 withregard to the said injuries, my husband/C.W.1 informed me that, while he was returning to his residence, near Kanti Stream, Accused and C.W.4/P.W.1 were quarreling with eachother, wherein Accused was assaulting C.W.4/P.W.1, on dragging her, leading to outraging her modesty, at that time, he/C.W.1 went to pacify the quarrel and rescued C.W.4/P.W.1 from the hands of the Accused, the Accused on having nurtured vengeance, abused him/C.W.1 in filthy language, taking the

name of the Caste; and assaulted him with the Axe; and C.W.4/PW.1 and C.W.5 pacified the quarrel.

It is false to suggest that, thereafter C.W.1 was admitted to Civil Hospital Vijayapura for treatment.

It is false to suggest that, thereafter I came to know that, C.W.1 has lodged the Complaint against the Accused.

It is false to suggest that, I am deposing falsely that, Accused has not assaulted my husband/C.W.1 with the Axe; and my husband/C.W.1 has not sustained any Cut and Bleeding injuries on his Head, Left Hand and Left Leg.

It is false to suggest that, I have given Statement before DySP Indi on 17.09.2007 contending that, "ನಮ್ಮೂರು ಬೂದಿಹಾಳ ಪಿ ಎಚ್ ----- ಗಾಯ ಪಡಿಸಿದ್ದು ಇರುತ್ತದೆ". For identification, the said Statement is marked as Ex.P.5.

It is false to suggest that, I am deposing falsely in this Case, inorder to help the Accused.

Examination-in-Chief by Ld. Spl. P.P.:

I know C.W.1, C.W.5 to 8.

I know the Accused present in the Open Court today.

I belongs to Hindu (Holer) Caste; and Accused belongs to Hindu (Talawar) Caste.

About 20 years back, in the evening at about 6.00pm, when I was returning to my residence on grazing the Sheeps, Accused was quarreling with C.W.1. I do not know for what reason both Accused and C.W.1 were quarreling.

Accused has not raised any quarrel with me.

I have not seen and heard Accused abusing C.W.1 in filthy language contending that, 'ಮಾದಿಗ ಸೂಳೆ ಮಗನೆ'; and assaulting C.W.1 with Axe, on his Head, Left hand and Left Leg, due which C.W.1 had sustained Cut and bleeding injuries.

Now Axe present in the Open Court is shown to the Witness and questioned her to identify it. Witness fails to identify the Axe. For identification, the said Axe is marked as M.O.1.

On the next day, when Sindagi Police had come to our village, I have shown the spot of incident. Police have not done anything on the spot, nor seized any material from the spot.

Sindagi Police have not enquired me in this Case and recorded my Statement.

(The Learned Spl. PP prays to treat this witness hostile. Perused the entire file and the examination-in-chief of this witness. Hence permitted)

Cross Examination by Learned Spl. PP.

It is false to suggest that, on 16.09.2007 at about 6.00pm when I was near Kanti Stream in our village Budihal PH, Accused raised quarrel with me; when C.W.1 tried to pacify the quarrel, the Accused assaulted him with the Axe/M.O.1, on abusing him in filthy language on taking the name of his Caste; due to the said assault C.W.1 sustained Cut and Bleeding injuries on his Head, Left Hand and Left Leg, due to which C.W.1 was screaming; thereafter myself and C.W.5 pacified the quarrel and rescued C.W.1 from the hands of the Accused; and thrown the Axe/M.O.1 by snatching it from the hands of the Accused.

It is false to suggest that, thereafter C.W.1 was admitted to Civil Hospital Vijayapura for treatment.

It is false to suggest that, thereafter I came to know that, C.W.1 has lodged the Complaint against the Accused.

It is false to suggest that, I am deposing falsely that, I do not know the Axe/M.O.1 present in the Open Court today.

It is false to suggest that, on 17.09.2007, when Sindagi Police had come to our village, I have shown the spot contending that, Accused has raised quarrel with me; and had assaulted C.W.1 with the Axe/M.O.1 on the said Spot, for which Sindagi Police have conducted Spot Mahazar on the said spot; and seized Axe/M.O.1 from the spot; in the presence of two panchas viz., C.W.2 and C.W.3; the said Mahazar proceedings were conducted inbetween 8.00am to 9.00am in the morning.

It is false to suggest that, I have given Statement before DySP Indi on 17.09.2007 contending that, "ನನ್ನ ಊರು ಬಾದಿಹಾಳ ಪಿ ಎಚ್ ----- ದೌರ್ಜನ್ಯ ಮಾಡಿದ್ದು ಇರುತ್ತದೆ". For identification, the said Statement is marked as Ex.P.4.

It is false to suggest that, I am deposing falsely in this Case, inorder to help the Accused.
