as follows :

That, on 10.8.2016 at about 7:00 a.m., in front of the house of
Shekhappa Pattanshetti situated in Chimmalagi Part-2 village, you
accused Nos.1 to 8 were members of an unlawful assembly, the
common object of which was to commit an offence, and thereby
committed an offence punishable U/s.143 r/w Sec.149 of IPC, and
within the cognizance of Court of Sessions Judge of Special Court.

2. That, on the above said date, time and place, you
accused Nos.1 to 8 were members of unlawful assembly, and in
prosecution of the common object of such assembly, committed the
offence of rioting, and thereby committed an offence punishable
U/s.147 r/w Sec.149 of IPC, and within the cognizance of Court of
Sessions Judge of Special Court.

3. That, on the above said date, time and place, you accused Nos.1 to 8 were members of unlawful assembly, and in prosecution of the common object of such assembly, committed the offence of rioting, and at that time, you were armed with deadly weapons, like Iron Rods, Sticks and Stones and thereby committed an offence punishable U/s.148 r/w Sec.149 of IPC,

4. That, on the above said date, time and place, you accused Nos.1 to 8 were members of unlawful assembly and in prosecution of common object of such assembly, picked up quarrel with the complainant Parasappa and C.Ws 4 to 9 and wrongfully restrained them from proceeding further, and thereby committed an offence punishable U/s.341 r/w Sec.149 of IPC, and within the cognizance of Court of Sessions Judge of Special Court.

5. That, on the above said date, time and place, you accused Nos.1 to 8 were members of unlawful assembly and in prosecution of common object of such assembly, picked up quarrel with the complainant Parasappa and C.Ws 4 to 9, you accused No.3 voluntarily caused simple hurt to CW-5 Mahadevi by assaulting her with stick on her back and left hand, you accused No.4 voluntarily caused simple hurt to CW-6 Chandrakala by assaulting her with stick on her back and right leg, you accused No.5 voluntarily caused simple hurt to CW-9 Bhimaraya by assaulting him with stone on his head, hands and legs and you accused No.7 voluntarily caused simple hurt to CW-8 Neelamma by assaulting her with stick on her body, and thereby committed an offence punishable U/sec.324 r/w Sec.149 of IPC, and within the cognizance of Court of Sessions Judge of Special Court.

6. That, on the above said date, time and place, you accused Nos.1 to 8 were members of unlawful assembly and in

prosecution of common object of such assembly, picked up quarrel with the complainant and when C.Ws 4 to 9 came to rescue the complainant, you accused No.1 voluntarily caused grievous hurt to the complainant by assaulting him with Iron rod on his left hand and left leg, you accused No.2 voluntarily caused grievous hurt to the complainant by assaulting him with stone on his back, hands and legs; when CW-4 Hanamant came to rescue, at that time, you accused No.3 voluntarily caused grievous hurt to CW-4 by assaulting him with stick on his left hand shoulder, left leg and back, you accused No.6 voluntarily caused grievous hurt to CW-7 Dundawwa by assaulting her with Iron rod on her back and both hands, and thereby committed an offence punishable U/s.326 r/w Sec.149 of IPC, and within the cognizance of Court of Sessions Judge of Special Court

7. That, on the above said date, time and place, you accused Nos.1 to 8 were members of unlawful assembly and in prosecution of common object of such assembly, used criminal force on C.Ws 5 to 8 by name; Mahadevi, Chandrakala, Dundawwa and Neelamma respectively, by dragging their Saris with intent to outrage their modesty, and thereby committed an offence punishable U/s.354 r/w Sec.149 of IPC, and within the cognizance of Court of Sessions Judge of Special Court.

8. That, on the above said date, time and place, you accused Nos.1 to 8 were members of unlawful assembly and in prosecution of common object of such assembly, picked up quarrel with the complainant and you accused No.1 voluntarily caused grievous hurt to her by assaulting her with iron rod on her left hand and left leg, and accused No.2 voluntarily caused grievous hurt to complainant by assaulting her with stick on her back, hands and

legs, you accused No.3 voluntarily caused grievous hurt to CW-4 Hanamanth by assaulting with stick on her back, left hand shoulder and left hand when she came to rescue the quarrel and at that time you were within the knowledge that by the said act of assault, you had caused the death of persons, you would have been guilty of murder and thereby you committed an offence punishable U/s.307 r/w Sec.149 of IPC, and within the cognizance of Court of Sessions Judge of Special Court.

9. That, on the above said date, time place you accused Nos.1 to 8 were members of unlawful assembly and in prosecution of common object of such assembly, picked up quarrel with the complainant Parasappa by abusing him in filthy language and gave provocation knowingly that such provocation would cause him to commit breach of public peace, and thereby committed an offence punishable U/s.504 r/w Sec.149 IPC, and within the cognizance of Court of Sessions Judge of Special Court..

10. That, on the above said date, time and place, you accused Nos.1 to 8 were members of unlawful assembly and in prosecution of common object of such assembly, committed criminal intimidation against the complainant and C.Ws 4 to 9 by giving threat to their lives, and thereby committed an offence punishable U/s.506 r/w Sec.149 IPC, and within the cognizance of Court of Sessions Judge of Special Court.

11. That, on the above said date, time and place, you accused Nos.1 to 8 were members of unlawful assembly and in prosecution of common object of such assembly, abused the complainant Parasappa and C.Ws 4 to 9, who belongs to Scheduled Tribe community in filthy words by taking their caste name and thereby committed an offence punishable U/s.3(1)(x) of SC & ST

(PA) Act, 1989, and within the cognizance of Court of Sessions Judge of Special Court.

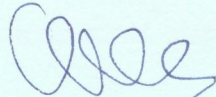
12. That, on the above said date, time and place, you accused Nos.1 to 8 were members of unlawful assembly and in prosecution of common object of such assembly, used criminal force on C.Ws 5 to 8 Mahadevi, Chandrakala, Dundawa and Neelamma, belonging to a Scheduled Tribe with intent to dishonor or outrage their modesty and thereby committed an offence punishable U/s.3 (1) (xi) of SC & ST (PA) Act, 1989, and within cognizance of Court of Sessions Judge of Special Court.

13. That, on the above said date, time and place, you accused Nos.1 to 8 were members of unlawful assembly and in prosecution of common object of such assembly, committed the offence under Indian Penal Code punishable with imprisonment for Ten (10) years or more against the complainant Parasappa and C.Ws 4 to 9 on the ground that, they belonging to Scheduled Tribe, and thereby committed an offence punishable u/s.3(2)(v) of SC & ST (PA) Act, 1989, and within the cognizance of the Court of Sessions Judge of Special Court.

So I hereby direct that you be tried by this court on the said charges.
