Now, Seizure Mahazar/Ex.P.13 is shown to the Witness and questioned him to identify, whether the said document contains his Signature. Witness answers in the Affirmative. On identification, Signature of the Witness is marked as Ex.P.13(b). Witness contends that he do not know the contents of the Seizure Mahazar/Ex.P.13.

Now a Positive Photograph/Ex.P.14 is shown to the Witness and questioned him to identify whether he is seen in the said Photograph. Witness answers in the Affirmative.

Now, witness step down from the witness box and went to see the Scorpio vehicle bearing REG No.KA-48/M-0707/M.O.6, parked in the Court Premises; enters Witness box, took oath and contended that, no any such vehicle was seized in his presence.

Now, Seizure Mahazar is shown to the Witness and questioned him to identify, whether the said document contains his Signature. Witness answers in the Affirmative. On identification, Seizure Mahazar is marked as Ex.P.13 and Signature of the Witness is marked as Ex.P.13(a). Witness contends that he do not know the contents of the Seizure Mahazar/Ex.P13.

Now a Positive Photograph is shown to the Witness and questioned him to identify whether he is seen in the said Photograph.

Witness answers in the Affirmative. On identification, the said photograph is marked as Ex.P.14.

Now, witness step down from the witness box and went to see the Scorpio vehicle bearing REG No. KA-48/M-0707, parked in the Court Premises; enters Witness box, took oath and contended that, no any such vehicle was seized in his presence. Now Seizure Mahazar/Ex.P.5 is shown to the Witness and questioned him to identify, whether the said document contains his Signature. Witness answers in the Affirmative. On identification, Signature of the Witness is marked as Ex.P5(b). Witness contends that he do not know the contents of the Seizure Mahazar/Ex.P.5.

Now two Positive Photographs/Ex.P6 and 7 are shown to the Witness and questioned him to identify whether he is seen in the said Photographs. Witness answers in the Affirmative.

(Now the sealed materials are unsealed in the presence of the Learned PP for the State and Sri. MANK., Adv for Accused Nos.1 to 5; and Smt. DRB Adv for Accused No.6 and found Two Langs and two Long Knives). Now the said materials have been shown to the witness and questioned him to identify them. Witness fails to identify the said material objects. For identification, both the Langs are marked as M.O.1 and 2; and two Long Knives are marked as M.O.3 and M.O.4.

Now, witness step down from the witness box and went to see the Scorpio vehicle bearing REG No. KA-28/N-2300, parked in the Court Premises; enters Witness box, took oath and contended that, no any such vehicle was seized in his presence. For identification, Scorpion Vehicle bearing REG No. KA-28/N-2300 is marked as M.O.5.

Golgumbaz Police have not enquired me in this Case; and I have not given any Statement before it.

(The learned PP prays to treat this witness hostile. Perused the entire file and the examination-in-chief of this witness. Hence permitted)

Cross Examination by learned PP

It is false to suggest that, On 08.02.2021, I and C.W.4/P.W.4 were called to Golgumbaz Police, wherein Accused Nos.1 to 5 were present in the said Police Station; wherein Accused Nos.1 to 5 expressed that, they will show the Langs and Knives and one Scorpio Vehicle used for committing the offence; accordingly, the Accused

persons took us and the Golgumbaz Police officials near Central Prison, Vijayapura and take us to the place, where bushes were there and shown the Scorpio Vehicle bearing REG No.KA-28/N-2300, wherein Accused No.4 contended that, he is the driver of the said Vehicle; front, rear and side glasses of the vehicle were broken; Accused No.1 produced one Lang from the said Vehicle; Accused No.2 produced one Knife; Accused No.3 produced one Lang and Accused No.5 produced one Knife; the said Vehicle and articles were seized by Golgumbaz Police by conducting the Seizure Mahazar as per Ex.P.5; got clicked two Positive Photographs as per Ex.P.6 and Ex.P.7; in my presence as well as in the presence of C.W.4/P.W.4; the said Mahazar proceedings were conducted inbetween 4.30 to 5.30pm in the evening.
