**Examination-in-Chief by Ld. P.P.:**

I am having three children viz., Hasanain/C.W.1/P.W.2, Ayaan (deceased); and a daughter by name Saniya. My both the sons were learning A/C repair works.

I know C.W.2, 3, C.W.8/P.W.1, C.W.9, 11 to 14.

I know the Accused, who is present today through V.C.

Accused used to visit Pune, to meet Muskan.

About 2 years back, C.W.9, C.W.8/P.W.1, C.W.2, 3, alongwith my sons had come to attend the marriage of Mohammad Kaif at Vijayapura. The said marriage was scheduled in a marriage hall. When my sons have come to attend the marriage, I was at my residence at Pune.

My elder son/Hasanain/C.W.1/P.W.2 called me over phone and informed me that, my another son/Ayaan has sustained stab injuries on his neck and on his stomach, blood is oozing, no medical Hospitals

is entertaining; and he is not in a position to stand. I informed my son/C.W.1/P.W.2 to take my another son to the Hospital. Even my son/Hasanain/C.W.1/P.W.2 has informed the name of the Accused that, he has assaulted my son/Ayaan. On hearing the said information, myself, C.W.11 to C.W.13 came to Vijayapura by Car; we went to the Police Station (Chowki), but I do not know the name of the said Police Station. I have seen my son/Ayaan who had sustained injuries, on the right side of the Neck, right side of the Stomach; and stabbing was done by giving several blows. My son/Hasanain/C.W.1/P.W.2 and Rushi (whom we call him with his pet name, who is shown as the eye witness in this Case). When I enquired Rushi, he informed that, after marriage we had gone to have Cold Drinks to a Cold Drink shop, wherein he had gone to bring the Cold Drinks; and my son/Ayaan was standing on the Road; Accused came and assaulted my son/Ayaan.

Vijayapura Police have enquired me in this Case; and read over the contents of the document written in Kannada Language to me in Hindi.

Accused has caused assault upon my son/Ayaan, since the engagement of the Accused with Muskan was breakdown; and the mother of Muskan had assured to give her daughter Muskan to my son/Ayaan.

**(The learned PP prays to treat this witness Partly hostile. Perused the entire file and the examination-in-chief of this witness. Hence permitted)**

**Cross Examination by learned PP**

It is true to suggest that, the house of Mehaboob Shaikh is situated besides my residence. It is true to suggest that, Muskan is the daughter of said Mehaboob Shaikh.

It is true to suggest that, when Accused had come to Pune to meet Muskan, at that time, Muskan and my son/Ayaan were talking with each other; on seeing them Accused was displeased (Naraz). Subsequently, Engagement taken place inbetween Muskan and Accused was broke down.

It is false to suggest that, my son/Ayaan was the reason for break down of Engagement inbetween Muskan and the Accused; and due the said reason, Accused has nurtured vengeance against my son/Ayaan.

It is true to suggest that, my son/Ayaan and his friends had come to perform the marriage of Shoaib Kope/C.W.14.

It is true to suggest that, when my son/Hasanain/C.W.1/P.W.2 had called me over phone; it was 24.12.2024 at about 4.00pm in the evening.

It is true to suggest that, when we came from Pune, we went to Civil Hospital, Vijayapura; at that time, Kumar/C.W.8/P.W.1 who is called by us as Rushi was present alongwith my son in the said Hospital; I enquired both of them about the incident; and they have narrated the incident to me.
