Cross-Examination by Sri.BBY Advocate for Respondent

Totally 01A:10G of land is acquired for canal. I know content of my chief examination affidavit and documents produced by me. Prior to acquisition notice was issued. No joint survey conducted prior to acquisition.

I am residing at Bommanahalli village. It is true Government has paid the compensation as per the Sub Registrar Valuation. It is false to suggest that as other land owners have filed for reference application, I have also filed. I do not remember when I submitted reference application. It is false to suggest that I have not filed the reference application within the stipulated period.

It is true my land is dry land. It is true there will be difference between Deep Black Soil (ಯರಿ ಭೂಮಿ) and Red Soil (ಮದ್ದಿ/ಮರಡಿ ಭೂಮಿ). It is true there will be difference in value between dry land and wet land and also fertility. It is false to suggest that my land is less fertile than sale deed properties.

I do not know personally about the sale deeds produced by me. It is false to suggest that Dindwar is at the distance to 18 kms from my land. Witness volunteers that it is at 16 kms. It is false to suggest that Ingaleswar is at the

distance to 23 kms from my land. Witness volunteers that it is at 4 kms. It is false to suggest that Kuduresalawadagi is at the distance to 22 kms from my land. Witness volunteers that it is at 6 kms.

I have not produced any document to show the distance between sale deeded properties and my land. It is true Basavana Bagewadi is Taluka Headquarter. Normally in Taluka Head Quarters, land value will be more. Normally guntawise plots are sold for construction of building. It is true I have not produced any sale deeds of my village.

It is true Vijaypur Airport is at the distance to 35 kms from my land. It is true Kudagi NTPS is at the distance to 35 kms from my land. Normally guntawise plots are sold for construction of building.

It is false to suggest that without any documentary basis I am claiming higher compensation. It is false to suggest that I have produced documents which are not connected to my property only for the purpose of claiming higher compensation. It is false to suggest that I am deposing falsely and I have filed false affidavit and false petition.
