JUDGMENT

(Passed on 26th day of September, 2022)

The accused and his counsel appeared before the court, filed pursis vide Exh.2 and submitted that, he voluntarily wish to plead guilty. The accused submits that, it is his first offence and being poor less penalty be imposed upon him.

I have carefully gone through the charge-sheet submitted by police, it appears that, accused had driven his vehicle in a rash and

negligent manner and without permit. The plead guilty of accused appears to be voluntarily. The accused is not previously convicted. It is not submitted that, any other crime of same nature is pending against the accused. Hence, considering the nature of offence and submission of the accused, I pass the following order.

O R D E R

- 1] The accused **Shivram Totaram Pawar**, Aged about-32 yrs., R/o. Dabha Tanda, Tah- Hingna, District- Nagpur is convicted for the offence punishable under section 279 of Indian Penal Code and sentenced to undergo **simple imprisonment till rising of the Court** and to pay a fine of **Rs.1000/- (Rs. One Thousand Only)**, in default to suffer **S.I.(Simple Imprisonment) for One Month.**
- 2] The accused **Shivram Totaram Pawar**, Aged about-32 yrs., R/o. Dabha Tanda, Tah- Hingna, District- Nagpur is convicted for the offence punishable under section 336 of Indian Penal Code and sentenced to undergo **simple imprisonment till rising of the Court** and to pay a fine of **Rs.250/- (Rs. Two Hundred and Fifty Only)**, in default to suffer **S.I.(Simple Imprisonment) for Fifteen Days.**
- 3] Both the substantive sentence shall run concurrently.
- 4] Dictated and pronounced in open court

(Collectively Fine of Rs.1,250/-)
