Further Cross examination: By Sri. A R, Advocate for Respondent

I do not remember when IA no. 2/2023 and IA no. 3/2023 filed before Hon'ble family court. It is false to suggest that these application filed by me after conclusion of evidence. I did not remember when evidence was closed. After filing of IA no. 2/2023 and IA no. 3/2023 I have not lead any evidence, I lead evidence before filing of these IAs. I have not filed any separate petition exclusively for return of my gold ornaments. It is true to suggest that in this petition also I have claim for return of my gold ornaments later I filed application before the family court in MC no.745/2013 for return of gold ornaments and it was allowed.

It is true to suggest that I have filed application seeking permanent alimony in the event divorce was granted. It is false to suggest that in a Criminal case filed against respondents alleging dowry harassment and I had also filed application for return of gold. Witness voluntaries that respondent not return the gold. It is false to suggest that my entire theory of gold that respondent have my gold it is a created story. It is false to suggest that I had not bought any gold to the respondent's house despite that to harass them I had created this story.

It is false to suggest that after filing of Ex.P.39 respondent asked me to visit his house and take all my belongings. It is true to suggest that respondent no.1 had filed memo before Hon'ble family court as per Ex.P.46 that he is ready to return all my belongings witness voluntaries that he had not mention all belongings. It is false to suggest that respondent as per Ex.P.46 intended to return my belongings

and It is false to suggest that deposing false before the court. Respondent's native place Ichapur and my native place is chandan nagar. The distant b/w both places road approximately 80-90 km. My native place is situated in Hoogli district and respondent native place is situated in North 24 paragona district.

Q:Have you ever made any effort to visit respondent's house after Dt:22-11-2024 to collect your belongings?

Ans: Since respondent no.1 filed divorce petition before family court, Bengaluru and execution was filed before the same case. He has to return the items before the same court.

I have not informed my parents respondent asked me to collect my belongings as they are sick and bed ridden. My younger sister is residing with my parents. We are residing in a joint family. I have 2 uncles. In one one floor one one family are there. I have not informed my parents about collecting my belongings from respondent as they are sick and bed ridden. I have not produced any documents to show that my parents are sick and bed ridden. It is false to suggest that respondent place is just 30 km away from my place and 9 km away by motor cycle.
