ORDER ON MAIN PETITION

The Petitioner filed this Petition U/Sec.13(3) of the Registration of Birth and Deaths Act, 1969.

It is alleged in the petition that, petitioner husband by name **Ismayil S/o Moulasab Walikar was died on 27.10.2024 at Sankanal Village, Basavan Bagewadi Taluk** and the same has not been entered in the Birth & Death Register of the respondent.

In spite of service of summons respondent remained absent & hence they placed ex-parte.

Petitioner No.1 herself has given evidence as PW-1 & has produced the Non-availability Certificate at Ex.P-1, Family Genealogy at Ex.P.2, Two Newspaper publications at Ex.P.3 and Ex.P.4, Adhaar Card at Ex.P.5 and Ration Card at Ex.P.6.

I have perused the records and the evidence of petitioners, there is no resistance from the respondent and there is no material to disbelieve the evidence of PW-1.

By taking into consideration of the observation made in a decision reported in **2000(4) KCCR 2674**. I find that there is no impediment to allow the petition depending upon the evidence of the petitioners. Hence I proceed the following order.

ORDER

The Petition is allowed. Respondent is hereby directed to issue Death Certificate of petitioners husband by name **Ismayil S/o Moulasab Walikar was died on 27.10.2024 at Sankanal Village, Basavan Bagewadi Taluk.**

Direction to the office, issue intimation to the respondent to issue Death Certificate accordingly after collecting necessary late fee from the petitioners.

Office to return original documents if any to the petitioners after careful verification and after obtaining certified copies of such documents.
