Particulars of offence are read over and explained to accused to which he pleads guilty voluntarily. By filing application at Exh.2 accused prayed for leniency, contending that he is labour and work as daily basis wages. He also prayed that this is his first offence, he is poor and only earning member of his family.

2. Record shows that, accused was found driving the Motorcycle bearing registration No. MH-39-Q-1016 under the influence of liquor of public road. Prosecution has not brought on record any material to show that accused was previously convicted for the same offence. Therefore, considering the nature of the offence and prayer of accused following order will meets the ends of justice.

ORDER.

The accused is hereby convicted for the offence punishable under section 185 of the Motor Vehicles Act vide section 252 of Code of Criminal Procedure and he is sentenced to imprisonment till rising of court and to pay fine of Rs. **1,000/-** (Rs. One Thousand Rupees only) in default Suffer Simple Imprisonment for 10 days.
