ORDER

Today, accused **Gokul Somnath Dhotre** is present. When the particulars of offence u/s 185 of Motor Vehicles Act were read over to accused, he voluntarily pleaded guilty. He also filed an application stating that he is voluntarily pleading guilty to the said offence and prayed to impose minimum punishment. Considering the nature of offence and taking in view the voluntariness of accused, his plea of guilt is accepted and leniency can be shown so far as substantive sentence of imprisonment is concerned. In the result, I pass following order:-

ORDER

1. Accused **Gokul Somnath Dhotre** is convicted for offence under section 185 of Motor Vehicles Act and is sentenced to imprisonment of Till Rising of Court and is also directed fine of Rs. 1000/- vide section 252 of Code of Criminal Procedure. In default to pay fine amount, accused shall suffer S.I. for 07 (seven) days.
2. No order as to muddemal.
