ORDER

Acting U/s 275 of BNSS. accused is convicted for the offences punishable Under sec.281 125(a) and 125(b) of BNS and 187 of IMV act.

The accused is sentenced to pay fine of Rs.**500/-** for the offence punishable U/Sec.281 of BNS. In default of payment of fine amount she shall undergo simple imprisonment for 1 day.

The accused is sentenced to pay fine of Rs.**2,500/-** for the offence punishable U/Sec.125(a) of BNS. In default of payment of fine amount she shall undergo simple imprisonment for 5 days.

The accused is sentenced to pay fine of Rs.**5,000/-** for the offence punishable U/Sec.125(b) of BNS. In default of payment of fine amount she shall undergo simple imprisonment for 10 days.

The accused is sentenced to pay fine of Rs.**2500/-** for the offence punishable U/Sec.187 of IMV Act. In default of payment of fine amount she shall undergo simple imprisonment for 5 days.

Total fine of Rs.10500/-
