1. The accused **Sajan Mahadu Jadhav** is hereby convicted for the offence punishable under Section 185 of Motor Vehicle Act vide Section 252 of the Code of Criminal Procedure and sentenced to pay fine of Rs.2000/- (Rupees Two Thousand only). In default of the fine, he is to suffer simple imprisonment of 15 days.
2. Copy of the Judgment be given to the accused forthwith free of costs.
