Claim Petition : U/s 64 of the Right to Fair Compensation and  
Transparency in Land Acquisition, Rehabilitation  
and Resettlement Act, 2013

This reference is coming on this 07<sup>th</sup> day of March - 2026 for final disposal before Sri.A.EARANNA, M.Com., L.L.M., District & Sessions Judge, Yadgiri in the presence of Sri. B.B. Helawar, Advocate for claimant, Sri. M.S.P Advocate for Respondent No.1, DGP for R-2, Sri. S. N. Advocate for Respondent No. 3. It is ordered that.

The claim petition filed U/sec.64 of the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013, are hereby partly allowed with costs.

The claimant is entitled to the enhanced market value from Rs.91,080/- to Rs.8,40,000/- per acre of dry land situated at Yanniwadagera village Tq. Shorapur Dist.Yadgir subject to deposit/payment of compensation if any.

The claimant is entitled for 100% solatium to enhanced market value under section 30(1) and 1<sup>st</sup> Scheduled the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

The claimants is entitled to two fold of the market value as per 1<sup>st</sup> Scheduled the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

The claimant is entitled to additional market value at the rate of 12% per annum on the enhanced market value.

The claimant is entitled to 9% of interest per annum of the enhanced market value as per Sec.72 of Right of Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.

Further, the claimant is also entitled for payment of interest at the rate of 15% per annum per section 80 of Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013.
