COMMITMENT ORDER

1. The accused Rahul Kumar and Jony have been forwarded to this Court by the SHO of P.S. Sadar Nakodar for facing trial for the commission of offences punishable under Section 379-B,411,34 IPC in FIR No.56 dated 13.05.2024.

2. Factual matrix of the prosecution case is that the present case has been registered against the accused on the basis of statement suffered by complainant Harpreet Singh son of Jaspal Singh resident of Dherian,

PS City Nakodar, District Jalandhar on the facts that he is resident of above-said address and is agriculturist by profession. He has taken four acre land situated at village Shankar owned by Mohan Singh who resides in England, on contract basis for agriculture purpose. On 13.05.2024 he was irrigating the land at village Shankar along with his servant Sanjit son of Kari Sada resident of Gagoli, District Samastipur Bihar at present resident of Dherian. He further stated that his servant was sitting at motor. At about 12 : 00 P.M. in the afternoon, two young clean shaved persons came on the motor on motor cycle make Hero of black colour bearing registration No. PB-08-FB-2617. The pillion rider was having datar in his hand and he attacked on the head of servant of complainant with datar and as the complainant was seeing them, the above said persons fled away from the spot after snatching the mobile phone make I Tell of light green colour having sim No. 75499-41705. Then complainant took his servant Sanjit to Civil Hospital, Nakodar for first aid. Complainant was searching the above said persons at his own level and now he came to know that the above-said occurrence has been committed by the persons of their native village Allowal namely Rahul Kumar son of Mandeep Kumar resident of Allowal, PS City Nakodar, District Jalandhar and Jony son of Tarsem Lal resident of Allowal, PS City Nakodar. In the end, complainant prayed to take action against the above said persons. From the statement of complainant, offences under Section 379-B, 34 of IPC were made out and ruqa was sent to the police station for registration of FIR through PHG Shingara Singh. SI Harjit Singh along with other police officials and

complainant Harpreet Singh reached at the spot. Site was inspected and site plan was prepared. Statements of witnesses u/s 161 Cr.P.C were recorded. On 13.05.2024 accused Rahul Kumar and Jony were arrested. On personal search of accused Rahul Kumar from the right pocket of his pent mobile phone I Tel of light green colour was recovered. On personal search of accused Jony from his right dub one iron datar was recovered. SI Harjit Singh took into police possession mobile phone, motor cycle, RC and datar vide separate recovery memo. During investigation vide rapat No. 29 dated 13.05.2024 offence under Section 411 of IPC was added. The RC of the motor cycle bearing No. PB-08-FB-2617 make Splendor was got proved from RTA Office, Jalandhar. After completion of investigation, challan against the accused was presented in the court.

3. Copies of documents of challan have been supplied to the accused in compliance of Section 230 BNSS. free of cost against the statement of accused recorded separately.

4. From the scrutiny of challan/report under Section 173 of Cr.P.C. and documents attached, prima facie case under Section 379-B,411,34 IPC is found to have been made out, out of which offence under Section 379-B IPC is exclusively triable by the Learned Court of Session, therefore, the present case is committed to the Court of Learned Sessions Judge, Jalandhar for 06.08.2024. The jail authorities are directed to produce the accused Rahul Kumar and Jony before the Court of learned Sessions Judge, Jalandhar on the date fixed at 10 : 00 a.m. sharp. APP be notified about the commitment of the case and the case file complete in all
