JUDGMENT

(Delivered in open Court on 11.02.2023)

Today, the accused is present and voluntarily pleaded guilty. The particulars of the offence are read over and explained to the accused in vernacular to which he pleaded guilty. Heard the accused on the point of sentence. He has submitted that it is his first offence. He is only earning member of his family and not habitual offender. Therefore, prayed for leniency in awarding sentence. Considering the fact and circumstances, request and the nature of offence, I am of the opinion that accused has committed offence and after considering the nature of offence, the following sentence would be just and proper. Hence, the order.

ORDER

- 1) Accused is convicted for the offence punishable under Section 283 of IPC vide Section 252 of the Code of Criminal Procedure.
- 2) Accused is sentenced to pay fine of Rs.200/- for the offence punishable under Section 283 of IPC. In default of payment of fine accused is sentence to suffer simple imprisonment for 1 day.
