I Mallikarajun Ishwarappa Kamatagi, Senior Civil Judge & JMFC Shorapur, is framed accusation against you are as under:

CHARGE U/s 240 of CRPC

1. On 21.02.2019 at about 10-00 am Near the land of complainant at Hadanur Village, which is situated within the limits of Kembhavi Police Station, you accused No.1 to 10 in furtherance of your common object, being member of an unlawful assembly and there by committed an offence punishable u/s 143,147 R/w 149 of IPC and within my cognizance.

2. On the above said date, time and place you accused No. 1 to 10 in furtherances of your common object and abused in a filthy language to C.W-1,7 and 8 and there by gives provocation will cause them to break the public peace and thereby committed an offence punishable u/s 504 R/w 149 of IPC and within my cognizance.

5. On the above said date, time and place you accused No. 1 to 10 in furtherances of common object and posed life threat and thereby committed an offense punishable U/s 506 R/w 149 of IPC and within my cognizance.
