under the law.

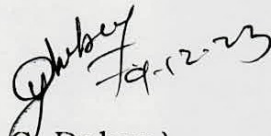

3(18) 1. Accused is convicted for the offence punishable under section 185 of the Motor Vehicles Act, vide section 252 of the Criminal Procedure Code and sentenced to pay fine of Rs. 2500/- (Two thousand rupees only), in default to suffer 15 days simple imprisonment.
