Examination in chief by Public Prosecutor:

1) I know CW 2, about 2 years back from now Shorapur police called me and CW 2 to act as a pancha at the spot situated in the land belongs CW 1, CW 5 shown the spot to the police and police conducted spot panchanama, and seized blood stained mud and non blood stained mud and iron spinkler from the spot in our presence, now I seen the said spot panchanama which bears my signature, witness identified his signature on panchanama and panchanama is now marked at Ex.P 2 and signature is marked Ex.P 2(a), the photos now shown to me reflects my photo, witness identified his photo in the photo shown to him, same are marked at Ex.P 3 and 4. witness identified iron spinkler pipe, same is already marked as MO. 1.

2. again after one week police called me to act as a pancha in the Shorapur police station and police conducted seizer panchanama in my presence and in the presence of CW 2 and seized cloths of deceased one blue color shirt, one blue color lungi, one blue color under wear, one waist

thread, now I seen the panchanama which bears my signature, witness identified his signature on panchanama and panchanama is marked Ex.P 5, and signature of witness marked at Ex.P 5(a), witness identified said 3 cloths and one red color waist thread, same are already marked at Ex.P 2 to 5. on next day again police called me to police station and police conducted seizer panchanama in my presence and in the presence of CW 2 and seized serang in plastic bottle, now I seen the panchanama which bears my signature, witness identified his signature on panchanama and panchanama is marked Ex.P 6, and signature of witness marked at Ex.P 6(a), witness identified said 2 serang kept in plastic bottle, same are already marked as MO. 6. except this I do not know anything about incident.

(At this stage the Ld. SPP prays to treat this witness as partly hostile, heard and perused, witness treated as partly hostile and permitted for cross examination)

Cross examination by P.P:

2) it is true to suggest that police have conducted inquest panchanama on dead body of deceased Yallappa in my presence and in the presence of CW 2, at Shorapur Govt. Hospital and I put my signature on inquest panchanama, and witness identified inquest panchanama and his signature on inquest panchanama, same is marked at Ex.P 7, witness signature is marked at Ex.P 7(a), and police took photo of panchanama and witness identified his photo now shown to him, same is marked at Ex.P 8.

Cross examination by Sri. KAR Adv. For Accused :

the wife of deceased Yallappa is my younger sister. Complainant is my relative and he is close to me, we are helping each other. I can't say

date and time of panchanama, I can't say description of spot. I know contents of panchanama. It is false to suggest that I do know contents of panchanama. Witness against deposed that he do not contents of inquest panchanama. It is false to suggest that no panchanama conducted in my presence, no articles seized in my presence and in the presence of CW 2 and no photos taken in my presence by the police. It is true that generally the village farmers using MO. 1 for irrigation of their lands. The all colors cloths are available in any where. It is false to suggest that deceased and complainant used to cultivate lands belongs to other on crop share basis. It is false to suggest that there was a dispute between this complainant and deceased in connection with cultivation of lands on crops basis. It is false to suggest that accused is innocent. Accused used to scuffle with 4 to 5 villages, I can't say name of those persons with whom accused scuffle. No panchayat conducted in connection said scuffle. It is false to suggest that since deceased and complainant are my relatives hence I am deposing falsely against accused.
