Examination in chief by Spl. Public Prosecutor:

1) CW.6 is my mother in law, CW.7 is my son, CW.8 is my father in law, CW.9 is younger brother of my husband. CW.10 is my elder brother, CW.11 is younger sister of CW.6.

I know accused No.1 to 3 and Splitup accused No.4.(Accused No.3 is absent. EP filed and submitted that identification of accused No.3 is not disputed) My husband died about 15 years back by consuming pesticide. I have 3 children, Honnayya is my elder son. About 15 years back from now at 11.00 AM I was in my house, CW.7 my son Honnayya had come to house with crying and told me that accused No.1 assaulted to my husband with Crowbar (ಬಾರಕೋಲಿ) and accused No.1 took the deceased by assaulting with Crowbar to his house and tied him at the place where cattels are used to tied (cattle stable). Soon after that my self and CW.7 had been to the house of accused No.1 where accused No.1 tied the deceased, by the time I reached the spot my husband was tied to the Wooden stake where cattles tied. I saw injuries on body of my husband and blood was oozing. Accused No.1 was present at the spot when I went their and I did asked the accused No.1 as to why you have

tied my husband, he told me that due to non payment of handloan of Rs.1000/- he tied my husband and assaulted. At that time I assured accused No.1 for repayment of said loan and requested the accused No.1 by touching his feet to leave my husband, at that time accused No.2 and 3 and splitup accused No.4 had come to the spot and told to the accused No.1 don't leave the deceased till repayment of handloan of Rs.1000/- and they abused in filthy language to my deceased husband by saying ಸೊಲೀ ಮಗನೇ. And accused No.2 to 4 abused so and told to accused No.1 don't leave him, at that time I requested accused No.1 to leave my husband and I will repay the said loan amount, at my request accused No.1 leave my husband stating that, if he(deceased) not paid the said loan amount he will kill my husband and by saying so he left my husband.

I took my husband to my house from the spot, in our house my deceased husband told me that accused No.1 gave a lifethreat that if I not paid amount he will kill me and hence I will do something to my life. Further my deceased husband told me that accused person assaulted him and he sustained severe injuries and he is not in a position to sustain pain and he was insulted at the hands of accused persons, but I convinced my husband don't do such things we will made arrangement for the said loan amount. On the next morning at 9.00 AM my husband consumed pesticide, on account of which my self, CW.6, 11 and my aunt by name Bassamma W/o Bassappa took my husband to Govt. Hospital Shorapur and admitted him, doctor given treatment to my husband. On the same day at evening 05.00 PM my husband died in the said hospital during treatment.

Thereafter I went to police station and lodged the complaint, which bears my thumb mark. Now I seen my complaint, witness identified her complaint and same is marked at Ex.P1 and witness identified her thumb mark on Ex.P1. Thereafter we took the dead body of my husband to our village and performed benaul of my husband. After one week police had come to our village near bustand and crowbar was found near bus stand and police seized the same in

my presence and went away, I can identify the same if shown. Witness identified accused No.1 and 2 who are present before the Court, witness deposed that she can identify accused No.3 and splitup accused No.4 if shown. (Accused No.3 is absent. EP filed and submitted that identification of accused No.3 is not disputed).

Property not produced hence further chief is deferred.
