CHARGE

I, **Yamanappa Bammanagi**, B.A.LL.B (Spl)., II nd Addl. District and Sessions Judge Yadgir, sitting at Shorapur, do hereby charge you;

1. Timmanna S/o Mareppa Bayiballar,
Age: 32 years, Occ: Farmer,
R/o Rattal village, Shorapur, Dist: Yadgiri.
2. Chandappa S/o Bheemanna Dharemani,
Age: 30 Years, Occ: Farmer,
R/o Rattal village, Shorapur, Dist: Yadgiri.

As follows;

1. That, on 21.01.2025, 06.30 pm, when complainant and his son Hanamanth were going on their motorcycle to purchase diesel for their tractor when they there on the road leading from Rangampeth to Rattal near Choudry Well at that time, you accused No.1 and 2, came and restrained and abused in filthy language and you accused No.1 and 2 did not allow them to go to purchase the diesel and thereby you accused No.1

and 2 have committed offence wrongful restraint P/U/Sec.126 R/w Sec.3(5) of BNS, within the cognizance of this Court.

2. That, on the above said date, time and place, you accused No.1 and 2 with common intention to assault on complainant and his son, restrained the complainant and his son and you accused No.1 assaulted on complainant with iron rod with intention to caused grievous injury , and you accused No.2 assaulted with stick on back of complainant, at that time, his son came to rescued the complainant you accused persons assaulted on him, and thereby you accused No.1 and 2 have committed offence P/U/Sec.118(1) R/w Sec.3(5) of BNS, within the cognizance of this Court.

3. That, on the above said date, time and place, you accused No.1 and 2 with common intention to assault on complainant and his son, restrained the complainant and his son and you accused No.1 assaulted on complainant with hands intention to kill him, at that time, his son came to rescued the complainant you accused persons assaulted on him, and thereby you accused No.1 and 2 have committed offence P/U/Sec.115(2) R/w Sec.3(5) of BNS, within the cognizance of this Court.

4. That, on the above said date, time and place, you accused No.1 and 2 with common intention to assault on complainant and his son, restrained the complainant and his son and you accused No.1 assaulted on complainant with iron rod with intention to kill him, and you accused No.2 assaulted with stick on back of complainant, at that time, his son came to rescued the complainant you accused persons assaulted on him, and thereby you accused No.1 and 2 have committed offence of attempt to commit murder of complainant, P/U/Sec.109 R/w Sec.3(5) of BNS, within the cognizance of this Court.

5. That, on the above said date, time and place, you accused No.1 and 2 with a common intention to abuse in filthy language to complainant with a intention to insult complainant and thereby you accused No.1 and 2 have committed offence P/U/Sec.352 R/w Sec.3(5) of BNS, within the cognizance of this Court.

6. That, on the above said date, time and place, you accused No.1 and 2 with a common intention to abuse in filthy language and gave a life threat to complainant, and thereby you accused No.1 and 2 have committed offence P/U/Sec.351(2) R/w Sec.3(5) of BNS, within the cognizance of this Court.

And, I hereby directed that you are be tried by this Court for the above said charges.
