CHARGE

I, **Yamanappa Bammanagi**, B.A.LL.B (Spl), II nd Addl. District and Sessions Judge Yadgir, sitting at Shorapur, do hereby charge you;

1. Mallikarjun S/o Ningappa Bovi,
Age: 22 Years, Occ: Car Driver,
2. Siddamma W/o Ningappa Bovi,
Age: 54 Years, Occ: Far, and house work, Both are
R/o Musturadoddi Kavadinatti, Tq: Shorapur,
Dist: Yadgiri.
3. Malamma W/o Devappa Kodesur,
Age: 29 Years, Occ: Coolie,
4. Devappa S/o Siddappa Kodesur,
Age: 33 Years, Occ: Agri, Both are
R/o Mallabhavi, Tq: Shorapur,
Dist: Yadgiri.

As follows;

1. That, prior to 25.08.2023, when victim was residing in her parents house at Mallabhavi village, due to matrimonial dispute between herself and her husband, at that time, you accused No.1 used to come to Mallabhavi village to meet your

relatives, at that time, you accused No.1 used to see at victim and used to talk to her closely and when she was alone in her parents house you accused No.1 asked her to give divorce to her husband and you accused No.1 promised her to marry with her after her divorce, she refused to marry with you accused No.1 as she has already married and she has one daughter from her husband, but, you accused No.1 did not heed and continued the same knowingly well that she is married woman and you accused used to enticed her with intent that, she may have illicit intercourse you accused No.1 and with a intention to have intercourse with her and thereby you accused No.1 has committed offence P/U/Sec.498 of IPC, within the cognizance of this court.

2. That, on 25.08.2023, at 01.00 pm, when victim was alone in her parents house at Mallabhavi village, you accused No.1 suddenly entered into her house and caught hold her with intention to commit offence of rape on victim, and thereby you accused No.1 has committed offence of house trespass P/U/Sec.448 of IPC, within the cognizance of this Court.

3. That, on the above said date, time and place, you accused No.1 after trespassing into the house of victim caught hold her, took her into one room and made her to lay on the ground and removed her saree, at that time she screamed and resisted, at

that time you accused No.1 abused in filthy language and gave a life threat and thereafter removed your pant and committed sexual intercourse on her forcibly, and after that, you accused No.1 used to come to her house whenever she was alone in her house, and used to commit sexual intercourse on her forcibly and repeatedly by giving false promise to marry with her, on account of which she be come pregnant, and thereby you accused No.1 committed offence P/U/Sec.376(2) (n) of IPC, within the cognizance of this Court.

4. That, on the above said date, time and place, when victim became pregnant due to sexual act of accused No.1 herself her parents came to your house and asked you accused No.1 to marry with her, at that time, you accused No.2 to 4 were present and you accused No.1 refused to marry with her, at that time, you accused No.1 to 4 abused in filthy language with intention to insult her, and thereby you accused No.1 to 4 have committed offence P/U/Sec.504 of IPC, within the cognizance of this Court.

5. That, on the above said date, time and place, when victim became pregnant due to sexual act of accused No.1 herself her parents came to your house and asked you accused No.1 to marry with her, at that time, you accused No.2 to 4 were present and you accused No.1 refused to marry with her, at that time, you

accused No.1 to 4 gave a life threat to finish her, and thereby you accused No.1 to 4 have committed offence of criminal intimidation, P/U/Sec.506 of IPC, within the cognizance of this Court.

6. That, on the above said date, time and place, when victim became pregnant due to sexual act of accused No.1 herself her parents came to your house and asked you accused No.1 to marry with her, at that time, you accused No.2 to 4 were present and you accused No.1 refused to marry with her, at that time, you accused No.2 to 4 gave a life threat and assaulted on victim with hands and thereby you accused No.1 to 4 have committed offence P/U/Sec.323 of IPC, within the cognizance of this Court.

And, I hereby directed that you are be tried by this Court for the above said charges.
