Examination in chief by Public Prosecutor:

1) Deceased Maremma is my younger sister, CW 12 is my father, CW 13 is my younger brother, CW 14 is my wife, CW 15 is elder brother of CW 14, accused is husband of deceased Maremma, I know accused who is present before the Court. Marriage between my sister deceased Maremma and accused took place 12 years back from now. After marriage my sister Maremma went to the house of accused to lead marital life with accused, and she gave a birth to two children, deceased Maremma was in her husband house for 8 years after her marriage with accused at Hirehall village. When deceased Maremma was in the house of accused, accused used to give harassment to the deceased on suspecting her chestity in intoxication condition, deceased Maremma used told us through phone about harassment of accused and she used to told us about harassment of accused whenever she had come to our house. My mother died 4 years back fro now. About 1 year back from now my deceased sister had come to our house at Shorapur for celebration of Ayudha pooje (Dasara festival),

she had come to our house 4 days prior to said festival. Accused also came to our house for said festival with deceased.

2) On 05.10.2025 myself, CW 14 with my 3 children were sleeping in our house at one room, in another room CW 12 and 13 were sleeping in the house, and accused and deceased were sleeping in another room our house at Shorapur in the night, on the said night I wake up for answering first nature call, it was about 1-45 am in the night hours, when I was wake up for answering first nature call my room door was locked out from the out side, hence I called CW 13 through phone and asked him to unlock the door, CW 13 also told me that his room door was also locked from the out side, hence I called CW 15 Suresh through phone and asked him to come to our room and unlock the door, said CW 15 came and open the door of our room, after that I came out from our room and went to the room of CW 13 and opened his room door, at that time I saw door of room where deceased and accused sleeping it was little open, hence I went to said room, when I was entering into the room of deceased accused suddenly come out from room with axe and pushed me and ran away from the house, I went inside the room of deceased, she sustained injuries on her neck and we found died deceased Maremma and fall in the blood. Thereafter we informed to the police, police had come to our house. Thereafter I went to Shorapur police station at 3-00 am and lodged the complaint against accused, and I put my signature on complaint, witness identified his complaint and signature, same is marked at Ex.P 1, signature of witness marked at Ex.P 1(a).

3) Thereafter police had come to our house and took the dead body of my deceased sister Maremma from the spot to Govt. Hospital Shorapur, the

photos now shown to me reflects dead body of my deceased sister, witness identified his photo in the photo shown to him, witness identified dead body of deceased in the said photos, same are marked at Ex.P 2 to 5. Thereafter police had come to our house and conducted spot panchanama, and I put my signature on panchanama, witness identified his signature on panchanama, said panchanama is marked Ex.P 6, and signature of witness marked at Ex.P 6(a). Police seized blood stained blanket from the spot, the photos now shown to me reflects blanket and view of room where deceased was sleeping with accused, witness identified his photo in the photo shown to him, and he identified blood stained blanket, said photo is marked at Ex.P 7. I can identify blanket, if shown, witness identified blood stained blanket, same is now marked at MO. 1. I can identify axe which was holding accused, if shown, witness identified blood stained and hairs axe, same is now marked at MO. 2.

4) I can identify cloths worn by deceased my sister at the time of incident, if shown, my deceased sister worn blue color nighty, one pink color skirt, witness identified blood nighty and pink color skirt, same are now marked at MO. 3 and 4. I can identify cloths worn by the accused on the date of incident, if shown, accused was worn white pant and white shirt, witness identified accused blood stained white shirt and white pant, same are now marked at MO. 5 and 6. Accused is the responsible for the death of my deceased sister Maremma.

Cross examination by Sri.DV. Adv. For Accused :

The Learned counsel for accused has filed petition U/s 254(3) of BNSS stating the grounds for adjournment of cross examination of witness till examination of CW 12 to 15, heard on both side, the ground stated in the petition are satisfactory, in order to hide the defense till

examination of CW 12 to 15 it is just and necessary to defer the cross examination of witnesses till examination of CW 12 to 15, hence petition allowed, cross of PW 1 deferred till examination of CW 12 to 15.
