**1)** Deceased Mallikarjun is my husband, CW.6 is my son, I know CW.7 to 12, I know accused person, who are present before the Court. My marriage took place about 27 years back from now. After marriage myself and my husband used to Bangle bussiness for 22-24 years, thereafter we left our business, thereafter my husband used to go for coolie work in bangles shop when ever called upon to do so. On 20.02.2024 my husband received call for CW.13 for coolie work in Tintani Mouneshwar fair on account of which my husband gone to Tintani on 21.02.2024 for coolie work in bangle shops belongs to CW.13. On 22.02.2024 at 06.00 am I received call for CW.13 and he told me accused and deceased took quarrel in drunken condition and asked me to come to Tintani, soon after receipt of said call myself and my son went Shorapur PS in our car and police told us to go to Shorapur Govt. Hospital we went their and I saw my husband in Govt. Hospital at Shorapur and I saw injuries on back side of near occipital, blood was oozing from the injuries. Blood found on face was dried. When I was in the said hospital I came to know from CW.9,

CW.9 was working with my deceased husband, he told me that, on previous night at 09.00 pm deceased my husband gone to answer second nature call and he came back to shop at 10.00 pm to 10.30 pm by the time he came to shop accused was taking meals at that time deceased scolded to the accused as to why you are taking meals without waiting for me, further CW.9 told me that when my deceased husband scolded accused in filthy language at that time accused became angry and abused in filthy language as ಸೂಳೀ ಮಗನೆ ನಿನ್ನ ಖಲಾಸ ಮಾಡುತ್ತೇನೆ and took iron rod and hit on occipital of deceased and caused injuries, thereafter owner of shop came and took the injured from the spot and when they were on way to hospital injured my husband died on the way. Thereafter I went to police station and lodged the complaint. Now I see the said complaint same is marked at Ex.P.1, witness identified her signature on Ex.P.1, same is marked at Ex.P1(a). The photos now shown to me are reflects dead body of deceased my husband, witness identified deceased in photos same are marked at Ex.P2 to 4. Accused is the responsible for the death of my deceased husband.
