CHARGE

I, **Yamanappa Bammanagi**, B.A.LL.B (Spl)., II nd Addl. District and Sessions Judge Yadgir, sitting at Shorapur, do hereby charge you;

Yankappa S/o Rangappa Shukla,
Age: 48 Years, Occ: Agriculture,
R/o Bailkunta, Now at Kumbar Benchi,
Tq: Hunasagi, Dist: Yadgiri.

As follows;

1. That, on 22.10.2023, at 10.00 pm, when complainant was setting in front of Yellamma temple at Kumbar Benchi village, (Bailkunti) to keep watch over the oil lamps which are lighted as part of celebration of Navatrathi festival, it was on 23.10.2023, at 10.30 am, in the mid night, you accused came holding axe and abused to the complainant in filthy language and assaulted with said axe on his occipital and chin and at left hand and caused bleeding injury, at that time, the complainant screamed and made hue and cry and cried for health, on hearing the same his son Ambresh and Rangappa

came and took him to hospital, and thereby you accused assaulted on complainant with axe on his vital part, with intention to commit murder of complainant and thereby you accused has committed offence of attempt to commit murder of complainant P/U/Sec.307 of IPC, within the cognizance of this Court.

2. That, on the above said date, time and place, you accused, it was on 23.10.2023, at 10.30 am, in the mid night, you accused came holding axe and abused to the complainant in filthy language and assaulted with said axe on his occipital and chin and at left hand and caused bleeding injury, at that time, the complainant screamed and made hue and cry and cried for health, on hearing the same his son Ambresh and Rangappa came and took him to hospital, and thereby you accused assaulted on complainant with axe on his vital part, and thereby you accused has committed offence P/U/Sec.326 of IPC, within the cognizance of this Court.

3. That, on the above said date, time and place, you accused after assaulting gave a life threat to complainant, and thereby you accused has committed offence, criminal intimidation, P/U/Sec.506 of IPC, within the cognizance of this Court.

4. That, on the above said date, time and place, you accused after assaulting abused in filthy language and intention to insult complainant and thereby you accused criminal intimidation, P/U/Sec.504 of IPC, within the cognizance of this Court.

And, I hereby directed that you are be tried by this Court for the above said charges.
