1) CW.4 is my younger brother, CW.5 and 6 are my sons, I know CW.7 and 8, I know accused who is present before the Court, accused is our relative, he is belongs to our village. There was a dispute between us and accused in connection with landed property. About 3 years back from now myself and CW.4 and 5 gone to Yallamma temple to keep watch over the lighting candles, it was about 12.30 am in the night hours when myself and CW.4 and 5 were in the temple the accused came with axe and abused in filthy language and assaulted on my occipital with axe and caused bleeding injury and assaulted on my chick with axe and caused bleeding injury and assaulted on my left forearm with axe, I screamed, on hearing the same CW.4 and 5 came to rescue me from hands of accused, at that time accused abused that, if you done same in the future I will finish you now you are rescued by your son and brother. Thereafter my son and brother took me to Rajanakollur Govt. Hospital, after taking preliminary treatment at Rajankollur Govt. Hospital I was reffered to Hunasgi Govt. Hospital for higher treatment, I took treatment at Hunasgi

Hospital and thereafter I was referred to District Hospital for Higher treatment, after taking treatment at Raichur again I was referred to Ballary Govt. Hospital and admitted me in the said hospital, when I was taking treatment in the said hospital at Ballary police had come and took my statement and I have stated in the statement before the police about the incident and put my signature on my statement, now I seen the said statement same is now marked at Ex.P1, witness identified his signature on Ex.P1 same is marked at Ex.P1(a). After taking treatment at Ballary Govt. Hospital I took treatment in private hospital at Bagalkote. I can identify axe used by the accused for assault if shown. Axe shown to the witness, witness identified the axe, same is marked at MO.1. accused assaulted on me with axe with a intension to kill me.

Cross examination by Sri.SSK Adv. For Accused :

At this stage the Counsel for the accused filed petition U/sec 231 of Cr.P.C(254(3) of BNSS) and sought permission to cross examined the witness after completion of chief examination of CW.4 to 8, the grounds stated in the are satisfactory, in order to protect the defence the petition is allowed and Ld. Counsel for accused permitted to cross examine CW.1 and 4 to 8 after completion of chief examination.
