CHARGE

I, **Yamanappa Bammanagi**, B.A.LL.B (Spl), II nd Addl. District and Sessions Judge Yadgir, sitting at Shorapur, do hereby charge you;

1. Akbar Patel @ Akbar S/o Murtujasab Mulla,
Age: 30 Years, Occ: Agri, R/o Malanoor,
Tq: Hunasagi, Dist: Yadgiri.
2. Murtujasab S/o Mahamdasab Mulla,
Age: 62 Years, Occ: Agri, R/o Malanoor,
Tq: Hunasagi, Dist: Yadgiri.
3. Dawalabi W/o Murtujasab Mulla,
Age: 52 Years, Occ: House hold, R/o Malanoor,
Tq: Hunasagi, Dist: Yadgiri.
4. Mainuddin S/o Bhasha @ Peersab Jamadar,
Age: 35 Years, Occ: Driver, R/o Aski,
Tq: Talikoti, Dist: Vijayapur.

As follows;

1. That, prior to 18.12.2022, you accused No.1 married with deceased Shaheena on 20.04.2018, you accused No.1 being husband of deceased Shaheena, and you accused No.2 to 4 being

in-laws of deceased, used to give physical and mental harassment to the deceased to bring more dowry and used to send her to her parents house, and used to force her to bring her to dowry, even after giving birth to two child, you did not stop dowry harassment to the deceased, about 06 month back from complaint, deceased came to her parents house for second time delivery, and after giving birth to second child, she came to your house, on 17.12.2022 deceased Shaheena called to her father through phone and told that, you accused No.1 being husband of deceased and accused No.2 to 4 gave a dowry harassment, and forced her to bring dowry and give mental and physical torture on her, and thereby you accused No.1 to 4 committed offence of cruelty on deceased Shaheena, P/U/Sec.498(A) R/w 34 of IPC within the cognizance of this Court.

2. That, on the above said date, time and place, you accused No.2 to 4 being in-laws of deceased, used to give physical and mental harassment to the deceased to bring more dowry and used to send her to her parents house, and used to force her to bring her to dowry, even after giving birth to two child, you did not stop dowry harassment to the deceased, about 06 month back from complaint, deceased came to her parents house for second time delivery, and after giving birth to second child, she came to your

house, on 17.12.2022 deceased Shaheena called to her father through phone and told that, you accused No.1 being husband of deceased and accused No.2 to 4 gave a dowry harassment, and forced her to bring dowry and give mental and physical torture on her, on account of which, on 18.12.2022 at 02.00 pm, in your house deceased Shaheena committed suicide by hanging, and thereby you accused No.1 to 4 committed offence of cruelty on deceased Shaheena and on account of which she committed suicide by hanging within 07 years from dated of her marriage, before her death she was subjected to cruelty and harassment at the hands of you accused No.1 and you accused No.1 to 4 being husband and relative of husband of deceased, and caused dowry death and thereby you accused No.1 to 4 committed offence P/U/Sec.304(B) R/w 34 of IPC within the cognizance of this Court.

3. That, on the above said date, time and place, you accused No.1 to 4 forced the deceased for bringing dowry and they used to ousted her from the house and thereby accused No.1 to 4 have committed offence P/U/Sec.3 of DP R/w 34 of IPC?

4. That, on the above said date, time and place, you accused No.1 to 4 forced the deceased for bringing dowry and

they used to ousted her from the house, and thereby accused No.1 to 4 have committed offence P/U/Sec.4 of DP R/w 34 of IPC?

And, I hereby directed that you are be tried by this Court for the above said charges.
