CHARGE

I, **Yamanappa Bammanagi**, B.A.LL.B (Spl)., II nd Addl. District and Sessions Judge Yadgir, sitting at Shorapur, do hereby charge you;

1. Basalingappa @ Raju S/o Manappa
Gopalapurakar, Age: 27 Years, Occ: Pvt. work,
2. Suresh S/o Shambhulingappa Kunte,
Age: 26 Years, Occ: Coolie work,
3. Mahadeva @ Madesh @ Mujib S/o Durgappa
Kattimani, Age: 20 Years, Occ: coolie work,
4. Laxmi @ Mallamma W/o Manappa Gopalapurkar,
Age: 51 Years, Occ: coolie work,
All are R/o Ramaji Nagar Rooj(K) Tq & Dist:
Kalaburagi

As follows;

1. That, you accused No.1, being son of deceased Manappa from his first wife accused No.4, had agreed each other to cause death of deceased Manappa and on account of which you accused No.1 and 4 agreed to pay Rs.2 lakhs to the accused No.2 and 3 to commit murder of deceased Manappa,

and as part of agreement, you accused No.1 and 4 has paid Rs.2 lakhs to accused No.2 and 3 and thereby you accused No.1 to 4 conspired to commit murder of deceased Manappa, and thereby you accused No.1 to 4 have committed offence of criminal conspiracy to commit an offence punishable with death, and committed offence P/U/Sec.120(B) R/w Sec.34 of IPC, within the cognizance of this Court.

2. That, on 12.05.2022, at 03.10 pm, when deceased Manappa was proceeding of his motor cycle towards Hiyala (B) village, when he was on motor cycle near the land of Shivappa Hudanoor situated within the limits of M.Kollur village, you accused No.2 and 3 as per criminal conspiracy came to the said spot and restrained deceased from proceeding towards Hiyal(B) village, and took him from his motor cycle and thereby you accused No.1 to 4 have committed offence P/U/Sec.341 R/w Sec.34 of IPC, within the cognizance of this Court.

3. That, on the above said date, time and place, you accused No.1 to 4, as per criminal conspiracy, restrained the deceased and and you accused No.2 and 3 took the deceased from his motor cycle, made him to lay on the grounds and assaulted with stone on his head and you accused No.3 stabbed with knife on deceased neck, and committed murder of

deceased and thereafter you accused No.1 took accused No.3 and 4 from the spot on your motor cycle and went away, and thereby you accused No.1 to 4 have committed offence of murder of deceased Manappa, P/U/Sec.302 R/w Sec.34 of IPC, within the cognizance of this Court.

4. That, on the above said date, time and place, you accused No.1 to 4, as per criminal conspiracy, restrained the deceased and you accused No.2 and 3 took the deceased from his motor cycle, made him to lay on the ground and assaulted with stone on his head and you accused No.3 stabbed with knife on deceased neck, and committed murder of deceased and thereafter in order to cause the evidence of commission of offence to disappear, you accused No.1 to 4, as per criminal conspiracy, attacked on the deceased on the way when he was going toward Hiyyal(B) village on his motor cycle and committed murder of deceased in the lonely place and thrown the dead body on the way, and thereby you accused No.1 to 4 have committed offence P/U/Sec.201 R/w Sec.34 of IPC, within the cognizance of this Court.

5. That, on the above said date, time and place, you accused No.1 to 4, as per criminal conspiracy, to commit to murder deceased Manappa you accused No.1 and 4 abetted

accused No.2 and 3 to commit murder of deceased and in consequences of your abetment the accused No.2 and 3 committed murder of deceased, and thereby you accused No.1 and 4 have committed offence P/U/Sec.109 R/w Sec.34 of IPC, within the cognizance of this Court.

And, I hereby directed that you are be tried by this Court for the above said charges.
