1) Deceased Nadagouda is my husband, I know deceased Basamma, I know CW.9 and 10, CW.11 is elder brother of my husband, CW.12 and 13 are my daughters, CW.14 and 15 are my in laws, CW.16 is my mother, CW.17 is my elder sister. I know accused No.1 to 3 who are present before the Court. My husband was doing agriculture work and he also elder of village and used to conduct panchayat in the local. 2 months prior to incident inquisition accused No.1 had come to our house and gave a threat to my deceased husband stating that, you had illciate relationship with my wife deceased Basamma and I will finish you one or other day, at that time my husband told to accused No.1 that, I never had such relationship with your wife and you pleased don't come to my house and don't suspect on me.

2) On 01.12.2022 at 01.00 pm my deceased husband told me that, he will go to our land and he went to our land, it was about 03.30 pm when I was in my house CW.10 Basamma came to our house who was working in

our land, CW.10 told me that, accused persons killed your husband and wife of accused No.1 Basamma in the land. Soon after that, myself CW.14 to 17 had been to our land and we found that my husband and wife of accused No.1 Basamma found dead in our land were cotton crops standing. I found injury on chin, on above left side eye, chick of my husband and found blood, deceased Basamma was sustained head injury. Thereafter we did enquire with CW.10, on enquiry CW.10 told us that, Accused No.1 assaulted below chin of deceased my husband with sickle, accused No.1 assaulted on left chick and above left eye of my husband with stone, Accused No.3 told to accused No.1 and 2 don't leave Nadagouda and Basamma and finished them. CW.10 told us that, accused No.1 and 2 assaulted on deceased Basamma with stone and they used to told that, deceased Nadagouda had illiciate relationship with Basamma and don't leave them.

3) Thereafter police had come to spot and took the deadbody of my deceased husband and deceased Basamma to Kembhavi and thereafter they took deadbodies to Shorapur. Thereafter I lodged the complaint against the accused persons, Now is seen the my complaint, with identified complaint, same is marked at Ex.P.1, witness identified her signature on Ex.P.1, same is marked at Ex.P1(a). The photos now shown to me reflects deadbody of my deceased husband and same are reflects are my photos and police officers and witness, same are taken in Govt. Hospital Shorapur, witness identified photos same are marked at Ex.P2 to 6.

4) On the next date police had come to our village and we shown the spot to the police and police have conducted spot panchanama and police took the photos of panchanama, witness identified said photos and same

are now marked at Ex.P7 to 36, police seized blood stained sickle from the spot and police seized 3 stones from the spot in the said panchanama, two blood stained and mud of deceased Nadagouda and deceased Basamma and one non blood stained mud, red colour broken bangle pieces of deceased Basamma, one pair Chappal belongs to my deceased husband, one mobile phone belongs to my husband, all articles seized from the spot are stained with blood except non stained mud, all articles seized from the spot by the police in the panchanama, witness identified the same, same are marked MO.1 to 10. I can identify the cloths worn by my deceased husband on the date of incident if shown, witness identified one sky blue shirt, one bunian, one green colour underwear, one blue colour lungi, one white colour towel, one yellow colour thread worn by my husband, one waist thread, one silver ring and one gold ring worn by my deceased husband and same are seized by the police, same are marked as MO.11 to 19. On the same day I have shown another spot in front of my house to the police and police have conducted spot panchanama, witness identified her signature on panchanama, said panchanama is marked at Ex.P.37 and witness identified her signature on Ex.P37, same is marked at Ex.P37(a) and police took photo of panchanama, witness identified photo of panchanama same is marked at Ex.P38.

5) The parents lands of deceased Basamma is adjacent to out land. Deceased Basamma was residing her parents house due to matrimonial dispute between herself and her husband. Accused persons killed my husband on suspect that, my husband had illiciate relationship with deceased Basamma who is wife of accused No.1.

Cross examination by Sri.RHK Adv. For Accused No.1 to 3.

The Ld.Junior counsel prays time for cross examination as his senior is out of station due to state Adv Bar Counsel election, time granted with cost of Rs.500/-.
