**CHARGE**

I, **Yamanappa Bammanagi**, B.A.LL.B (Spl)., II<sup>nd</sup> Addl. District and Sessions Judge Yadgir, sitting at Shorapur, do hereby charge you;

1. Chandrakant @ Chandra S/o Channappa Rathod, Age: 28 Years, Occ: Coolie, R/o Chamanal Tanda, Tq: Shahapur, Dist: Yadgiri.
2. Hallappa S/o Sanjeevappa Madar, Age: 24 Years, Occ: Coolie work, R/o Danda Solapur, Dist: Yadgiri.

As follows;

1. That, you accused NO.1 and 2 and deceased being friends, used to drink alcohol together, as such, on 30.05.2022, at 11.00 a.m, you accused No.1 and 2 and deceased were drinking alcohol in the bund of the land belongs to padgri, situated near Hanmanth Sahu School, at Chamnahall village, at that time, you accused No.1 asked the deceased as to why he has informed to one Laxmibai about the theft of bringle from her land, in this connection there was exchange of hot towards between you and deceased, on account of which, you accused No.1 took the stone and hit on

check of deceased, and deceased fell on the ground, at that time, you accused No.2 press his neck and at that time, you accused No.1 took one piece of saree found on throne bush and tied the neck of deceased with said piece of saree and due to which deceased died and thereby you accused No.1 and 2 committed murder of deceased Sachin, thereby you accused No.1 and 2 committed offence P/U/Sec.302 R/w 34 of IPC, within the cognizance of this Court.

**2.** That, on the above said date, time and place, you accused No.1 and 2 after committing murder of deceased Sachin, after coming murder of deceased, thrown the dead body of deceased Sachin in the bund of land belongs to one Padri to cause evidence of the commissioner of offence to dis-appeared and with intention of screening yourself from legal punishment, and with a intention to cause disappear the evidence of offence committed by you, and thereby you accused No.1 and 2 have committed offence P/U/Sec.201 R/w 34 of IPC, within the cognizance of this Court.

And, I hereby directed that you are be tried by this Court for the above said charges.
