**CHARGE**

I, **Yamanappa Bammanagi**, B.A.LL.B (Spl)., II nd Addl. District and Sessions Judge Yadgir, sitting at Shorapur, do hereby charge you;

Yallappa S/o Jatteppa Kolor,  
Age: 31 Years, Occ: Coolie,  
R/o Vandurga, Tq: Shahapur, Dist: Yadgiri.

As follows;

1. That, on 18.06.2024, at 05.30 pm, when complainant was coming towards her house, at Devapur after answering second nature call, when she was on the road near the house belong to nurse, at that time you accused, being friend of complainant's husband, came on your motorcycle bearing No.KA-33-K-3022, and told her that, her husband met with an accident in his Auto near Shantapur village, as he received call, under the said pretext you accused took the complainant/victim on your motorcycle, after crossing Shantapur village, when you took her towards Aralihalli village,

she suspected on you and requested you to stop the vehicle and asked you why you are taking in wrong route, but, you did not heed, hence victim jumped from running motorcycle and fell on the ground, and she sustained injuries, again you accused took her on your motorcycle though she resisted, screamed, but, you accused gave life threat and took her away from the said road and in one land, and thereby you accused kidnapped the victim with intention to commit rape on her, after committing the rape again you took her to Bangalore, when you kept in the house at Bangalore she came back, and thereby you accused has committed offence of kidnap P/U/Sec.363 of IPC, within the cognizance of this Court.

**2.** That, on the above said date, time and place, you accused, after kidnapping the victim to the said place, made her to lie on the ground and gave a threat, and removed her saree and underwear and committed sexual intercourse on her against her will and thereby you accused has committed offence P/U/Sec.376 of IPC, within the cognizance of this Court.

**3.** That, on the above said date, time and place, you accused, when you accused kidnapping the victim she requested you to stop the vehicle, you did not heed, hence she jumped from the vehicle, at that time, you accused assaulted on chest and back of her when she refused to come with you,

thereby you accused has committed offence, P/U/Sec.323 of IPC, within the cognizance of this Court.

**4.** That, on the above said date, time and place, you accused after kidnapping the victim you accused gave a life threat to her when she refused to come with you and sleep with you, and thereby you accused has committed offence, criminal intimidation, P/U/Sec.506 of IPC, within the cognizance of this Court.

**5.** That, on the above said date, time and place, you accused after kidnapping the victim you accused abused in filthy language and intention to insult her and thereby you accused criminal intimidation, P/U/Sec.506 of IPC, within the cognizance of this Court.

And, I hereby directed that you are be tried by this Court for the above said charges.
