CHARGE

I, **Yamanappa Bammanagi**, B.A.LL.B (Spl), II nd Addl. District and Sessions Judge Yadgir, sitting at Shorapur, do hereby charge you;

Yallappa @ Yallalinga S/o Yankappa @ Venkatesh
Jalibenchi, Age: 19 Years, Occ: Driver,
R/o Bichagattikeri Shorapur, Tq: Shorapur,
Dist: Yadgiri.

As follows;

1. That, 06 years back from the complainant/victim married with one Sharanappa belongs to Basavanthpur village, within 2 to 3 months of her marriage her husband left from the house, he did not come back, on account of which, the victim is residing with her mother her younger brother, in the house of her mother, situated at Venkatapur, Tq: Shorapur, and she used to go for Coolie work with her mother, in auto belongs to you accused, and you accused came to know the victim, whenever victim's mother and her younger brother gone for work she use to stay in

the house alone, as such, on one day you accused came to the house of victim when she was alone in the house and talked with her in sympathetic manner saying that, your husband left you at the young age and you have to live alone in the young age, and you to say so in many times, and on one day, when victim was alone in her house, and told her that, such incident should not happened in your life, and by saying so, you accused told her that, you like her and you wants to marry with her, at that time she refused and scolded and told you that, if you repeated the same she will informed her mother, and even then you accused started to tease her, and used to told her that you like her, and you wants to marry with her, though she refused and told that, she is already married woman, you did not heed and continued the same, but, due to reputation of family she did not disclosed the incident to her mother, as such, she used to sleep in the night in tin shed situated in front of her mother house, and her mother her younger brother used to sleep in the room, and you accused used to come to the shed and used to told her that, he will marry with her and used to have sexual intercourse with her on promise of marriage with force, on the last day on 01.03.2024, at 11.00 pm, when victim was sleeping in the shed you accused came and committed sexual intercourse forcibly, and thereafter the victim became pregnant for

06 months on account of which, she asked you to marry with her, but, you accused refused to marry with her, and thereby you accused committed offence of rape on victim, P/U/Sec.376(2) (N) of IPC within the cognizance of this Court.

And, I hereby directed that you are be tried by this Court for the above said charges.
