**CHARGE**

I, **Yamanappa Bammanagi**, B.A.LL.B (Spl)., II nd Addl. District and Sessions Judge Yadgir, sitting at Shorapur, do hereby charge you;

1. Basanagouda S/o Sanna Manayyagouda Mali Patil, Age: 30 Years, Occ: Agri, R/o Lingadalli village, Tq: Shorapur, Dist: Yadgiri.
2. Timmanna S/o Sanna Manayyagouda Mali Patil, Age: 40 Years, Occ: Agri, R/o Lingadalli village, Tq: Shorapur, Dist: Yadgiri.
3. Sharanu S/o Sanna Manayyagouda Mali Patil, Age: 32 Years, Occ: Agri, R/o Lingadalli village, Tq: Shorapur, Dist: Yadgiri.
4. Anilakumar S/o Sanna Manayyagouda Mali Patil, Age: 26 Years, Occ: Agri, R/o Lingadalli village, Tq: Shorapur, Dist: Yadgiri.
5. Ramalingappa S/o Paramanna Karnal, Age: 25 Years, Occ: Agri, R/o Lingadalli village, Tq: Shorapur, Dist: Yadgiri.

As follows;

1. That, on 03.07.2021, at 07.00 am, when complainant was in his house situated at Lingadalli SK village,

you accused No.1 to 5 formed unlawful assembly with common object to assault on complainant and his younger brother, you accused No.1 to 5, being member of unlawful assembly for the said common object and thereby you accused No.1 to 5 have committed offence P/U/Sec.143 R/w Sec.149 of IPC, within the cognizance of this Court.

**2.** That, on the above said date, time and place, you accused No.1 to 5, being members of unlawful assembly in order to prosecute common object of unlawful assembly, you accused No.1 to 5 came to the house of complainant holding axe and stick and abused in filthy language to the complainant and his younger brother and thereby you accused No.1 to 5 have committed offence P/U/Sec.147 R/w Sec.149 of IPC, within the cognizance of this Court.

**3.** That, on the above said date, time and place, you accused No.1 to 5, being member of unlawful assembly, in order to prosecute common object of unlawful assembly, came to the house of complainant by holding stick and axe abused in filthy language due to which the complainant closed door of his house from inside and at that time, you accused No.1 hit on door with axe and cut and damage the door and you accused No.2 holding axe and cut the threshold of the door and you

accused No.3 caused damaged to tiels and you accused No.4 and 5 holding sticks hit on scooty bearing No.KA-33-EA-4637 with stick and caused damaged to the said vehicle, with a intention to cause damage to the property belongs to complainant and thereby you accused No.1 to 5 committed offence of mischief, P/U/Sec.427 of IPC, within the cognizance of this Court.

**4.** That, on the above said date, time and place, you accused No.1 to 5, being members of unlawful assembly, in order to prosecute common object of unlawful assembly, you accused No.1 to 5 came to the house and caused damaged to the door of house belongs to complainant and cause damaged to the vehicle and tiels belongs to complainant and thereby you accused No.1 to 5 have committed offence P/U/Sec.148 R/w Sec.149 of IPC, within the cognizance of this Court.

**5.** That, on the above said date, time and place, you accused No.1 to 5, being member of unlawful assembly, in order to prosecute common object of unlawful assembly, and thereafter you accused No.1 to 5 gave a life threat to complainant and thereby you accused No.1 to 5 have committed offence, criminal intimidation, P/U/Sec.506 R/w Sec.149 of IPC, within the cognizance of this Court.

6. That, on the above said date, time and place, you accused No.1 to 5, being member of unlawful assembly, in order to prosecute common object of unlawful assembly, abused in filthy language and intention to insult complainant and thereby you accused No.1 to 5 have committed offence, criminal intimidation, P/U/Sec.504 R/w Sec.149 of IPC, within the cognizance of this Court.

And, I hereby directed that you are be tried by this Court for the above said charges.
