CHARGE

I, **Yamanappa Bammanagi**, B.A.LL.B (Spl)., II nd Addl. District and Sessions Judge Yadgir, sitting at Shorapur, do hereby charge you;

Ambresh S/o Nandappa Mulimani,
Age: 48 years, Occ: Coolie, R/o Benchigaddi
village, Tq: Hunasagi, Dist: Yadgiri.

As follows;

1. That, on 19.06.2025, you accused and deceased and his relative Ningappa cut the dry-wood sticks stoned near the house of complainant for domestic purpose, after the said work you accused and said Lingappa an deceased left from the house of complainant at 04.00pm, under the pretext to go for drinking alcohol in Heddalabayi Tanda, it was about 06.00 pm, when you, deceased and said Ningappa on the road near the land belongs to one Shubhanna Jadar of Hosur village, at that time, you accused asked the deceased to pay dry-wood cutting work Coolie, at that time, deceased told you that, he will pay

later on on account of which, you accused took the stick on hit on head of deceased with intention to kill him, at that time, said Ninganna came to rescue the deceased, at that time, you accused assaulted on said Ninganna with stick and hands on his left hand and left ear and caused the bleeding injury, due to assault on deceased with stick deceased died on the spot and thereby accused committed murder of deceased Ayyanna and committed offence P/U/Sec.103(1) of BNS, within the cognizance of this Court.

2. That, on the above said date, time and place, when you accused assaulted on deceased with stick, at that time, said Ningappa came to rescued the deceased from your hands, at that time you accused assaulted on said Ningappa on his left hands and left ear with stick and caused the bleeding injury, and you accused assaulted on said Ningappa with deadly weapons with intention to kill him, and thereby you accused has committed offence of attempt to commit murder of said Ningappa and committed offence P/U/Sec.109 of BNS, within the cognizance of this Court.

3. That, on the above said date, time and place, when you accused assaulted on deceased with stick, at that time, said Ningappa came to rescued the deceased from your hands, at

that time you accused assaulted on said Ningappa on his left hands and left ear with stick and caused the bleeding injury, and you accused assaulted on said Ningappa with deadly weapons, and thereby you accused has committed offence P/U/ Sec.118(2) of BNS, within the cognizance of this Court.

And, I hereby directed that you are be tried by this Court for the above said charges.
