Plea:- : Guilty

Finding:- : Guilty

Sentence/Order:- They pleaded guilty. For the offence punishable under Section 294 (b) of the Indian Penal Code both accused are sentenced to pay fine of rupees 500 each; In default, they shall undergo simple imprisonment for

a period of one day. For the offence punishable under Section 447 of the Indian Penal Code, A2 and A3 are sentenced to pay fine of rupees 500 each; In default, they shall undergo simple imprisonment for one day each. For the offence punishable under Section 323 of the Indian Penal Code, both A2 and A3 are sentenced to pay remit fine of rupees 1000 each; In default, they shall undergo simple imprisonment for one day each. For the offense punishable under Section 324 of the Indian Penal Code, both A2 and A3 are found guilty and are sentenced to pay fine of rupees 1000 each; In default, they shall undergo simple imprisonment for a period of one day each. For the offence punishment under Section 506 part 2 of the Indian Penal Code, both accused are sentenced to a fine of rupees 1000 each; and in default they shall undergo imprisonment for one day each. Total fine amount rupees 4000 each and to be paid by A2 and A3. The fine amount, if realized, shall be paid as compensation to the CW1- de facto complainant, Under Section 395 of the BNSS.

J U D G M E N T

A1 no more and charge against A1 abated. A2 and A3 present. Charge framed and read over to the accused. They pleaded guilty. For the offence punishable under Section 294 (b) of the Indian Penal Code both accused are sentenced to pay fine of rupees 500 each; In default, they shall undergo simple imprisonment for a period of one day. For the offence punishable under Section 447 of the Indian Penal Code, A2 and A3 are sentenced to pay fine of rupees 500 each; In default, they shall undergo simple imprisonment for one day each. For the offence punishable under Section 323 of the Indian Penal Code, both A2 and A3 are sentenced to pay remit fine of rupees 1000 each; In default, they shall undergo simple imprisonment for one day each. For the offense punishable under Section 324 of the Indian Penal Code, both A2 and A3 are found guilty and are sentenced to pay fine of rupees 1000 each; In default, they shall undergo simple imprisonment for a period of one day each. For the offence punishment under Section 506 part 2 of the Indian Penal Code, both accused are sentenced to a fine of rupees 1000 each; and in default they shall undergo imprisonment for one day each. Total

fine amount rupees 4000 each and to be paid by A2 and A3. The fine amount, if realized, shall be paid as compensation to the CW1-de facto complainant, Under Section 395 of the BNSS.
