This case coming on this day, the court passed the following:

ORDER

1. The final report is filed by the Sub Inspector of Police, Alappuzha South Police Station in Crime No.70/2026 of the said police station, alleging commission of

offences punishable u/s.115(2) of Bharatiya Nyaya Sanhita, 2023 (hereinafter referred to as 'BNS') and S.75 of Juvenile Justice Act (in short, 'JJ Act').

2. The prosecution case, in brief, is that, the accused who is duty bound to protect his children, on 01.02.2026 at 06:30 PM hit his 4 ½ years old younger child on her face with hands and hit 8 years old elder child on her left hand muscle part, thereby causing pain to children. The accused is thus alleged to have committed the offences.
3. The accused entered appearance, and he was enlarged on bail. Copies of all prosecution records were furnished to the accused, as per S.230 of BNSS.
4. On perusal of the prosecution records, this court is satisfied that the offence alleged is exclusively triable by the Hon'ble Sessions Court. Hence, the case is committed to the Hon'ble Sessions Court, Alappuzha, as provided u/s.232 of Bharatiya Nagarik Suraksha Sanhita, 2023.
5. The accused shall appear before the Hon'ble Sessions Court, Alappuzha, as and when directed.
6. The entire case records and material objects shall be forwarded to the Hon'ble Sessions Court, Alappuzha, forthwith. The office is directed to notify the learned Public Prosecutor, Alappuzha, as provided u/s.232(d) of Bharatiya Nagarik Suraksha Sanhita, 2023.
