COMMITTAL ORDER

1. This case stand charge sheeted by the Sub Inspector, Mannancherry Police Station in Crime No.1097/24 against accused alleging offence punishable under 189(2), 191(2), 191(3), 190, 296(b), 115(2), 118 (1), 110, 324(4), 351(3) of BNS
2. **Prosecution case in brief:-** Due to the animosity towards the informant , a staff of Enkey's Bar' at Pathirapally bar, that he questioned the accused persons, who had created commotion inside the Bar, on 31.10.2024 at about 4.40 p.m., the accused formed themselves into an unlawful assembly, armed with deadly weapons and in prosecution of their common object to cause hurt to the informant, A1 hurling abusive words, beat the informant with a beer bottle, which he evaded causing injury on right side of his head . Therafter A1 beat on his head with a knuckle duster. When on of the friends of informant named Syamji intervened in the incident, two among the accused, hit him. At that time, A3 to A6 beat the informant and said Syamji with hands and threatened to do away with him showing beer bottles. The accused destroyed the glasses of the bar and thereby caused a loss to the tune of Rs.30,000/- to the bar. Thus the accused are alleged to have committed the offences mentioned above .
3. A1 to A5 were arrested and produced before this court on 01.11.2024 and they were remanded to judicial custody on the same day. A1 and A2 were enlarged on bail as per the order of Hon'ble sessions court, Alappuzha in Crl.M.C 787/24 dtd 22.11.2024. A3 was enlarged on bail as per the order in CMP no.3591/24 dated 26.11.2024 by this Court. A3 was enlarged on bail as per the order in CMP no.3591/24 dated 26.11.2024 by this Court. A4 was enlarged on bail as per the order in CMP no.1097/24 dated 19.11.2024 by this Court. A5 was enlarged on

bail as per the order of Hon'ble sessions court, Alappuzha in CrI.M.C 761/24 dtd 16.11.2024.A6 was arrested and produced before this court on 27.11.2024 and he was remanded to judicial custody . Thereafter he was enlarged on bail as per the order in CMP no. 3693/24 dated 05.12.2024 by this Court.

4. On conclusion of investigation charge sheet was filed against the accused for the above said offences. Accused entered appearance on summons and filed memo stating that they are on bail. Copies of prosecution records were furnished to the accused in accordance with S.230 of the Bharathiya Nagarik Suraksha Sanhita, 2023.
5. On hearing both sides and perusing the prosecution records, this court is satisfied that the offence alleged is exclusively triable by the Court of Sessions and hence case is committed to the Hon'ble Sessions Court, Alappuzha u/S.232(a) of Bharathiya Nagarik Suraksha Sanhita, 2023. The accused is directed to appear before the Hon'ble Court of Sessions, as and when directed by that court.
6. The records and the properties involved in the case shall be submitted to the Hon'ble Court of Sessions forthwith, under Section 232(c) of the Bharathiya Nagarik Suraksha Sanhita ,2023.
7. Notify the commitment of the case to the Learned Public Prosecutor Alappuzha, under Section 232(d) of Bharathiya Nagarik Suraksha Sanhita, 2023.
