COMMITTAL ORDER

1. This case stands charge sheeted by the Sub Inspector, Mannancherry Police Station in Crime No.799/25 against accused alleging offences punishable under 115(2), 118(1), 109(1) and 118(2) of BNS.
2. **Prosecution case in brief:-** On 05.10.2025, at around 06.00 PM, the accused entered into a verbal altercation with his brother Saravanan and out of the said enmity the accused took a wood piece lying over there and hit him on his head with the intent to kill him .Thereafter , the accused beat him using the same wood piece shouting that he will kill him and when the neighbours attempted to took Saravanan to hospital the accused prevented them from taking him to hospital . Thus the accused is alleged to have committed the offences punishable under 115(2), 118(1), 109(1) and 118(2) of BNS.
3. Accused was arrested and produced before this court on 07.10.2025

and he was remanded to judicial custody on the same day. Thereafter the accused was enlarged on bail as per order of the Hon'ble Sessions Court in CrI.MC No.1474/25 dated 08.12.2025.

4. On conclusion of investigation charge sheet was filed against the accused for the above said offences. Accused entered appearance on summons and filed memo stating that he was on bail .Copies of prosecution records were furnished to the accused in accordance with S.230 of the Bharathiya Nagarik Suraksha Sanhita, 2023.
5. On hearing both sides and perusing the prosecution records, this court is satisfied that the offence alleged is exclusively triable by the Court of Sessions and hence case is committed to the Hon'ble Sessions Court, Alappuzha u/S.232(a) of Bharathiya Nagarik Suraksha Sanhita, 2023. The accused is directed to appear before the Hon'ble Court of Sessions, as and when directed by that court.
6. The records and the properties involved in the case shall be submitted to the Hon'ble Court of Sessions forthwith, under Section 232(c) of the Bharathiya Nagarik Suraksha Sanhita ,2023.
7. Notify the commitment of the case to the Learned Public Prosecutor Alappuzha, under Section 232(d) of Bharathiya Nagarik Suraksha Sanhita, 2023.
