COMMITTAL ORDER

1. This case stands charge sheeted by the Excise Inspector Excise Range office, Alappuzha in Crime No.141/24 against accused alleging offence punishable under 8(1), 8(2) of the Kerala Abkari Act
2. Prosecution allegation is that, on 22.11.2024 at 7.40 pm, 8 liters of arrack was seized from the house of accused namely Panam Thuruthu House at Mararikulam South panchayath in contravention of the provisions of the Abkari Act and thereby the accused is alleged to have committed the aforesaid offence.
3. Accused was not arrested during investigation. On completion of investigation , charge sheet was filed against the accused and on issuance of summons from this court , the accused appeared . After hearing both sides , the accused was enlarged on bail . Copies of prosecution records were furnished to the accused in accordance with

S.230 of the Bharathiya Nagarik Suraksha Sanhita, 2023.

4. On hearing both sides and perusing the prosecution records, this court is satisfied that the offence alleged is exclusively triable by the Court of Sessions and hence case is committed to the Hon'ble Sessions Court, Alappuzha u/S.232(a) of Bharathiya Nagarik Suraksha Sanhita, 2023. The accused is directed to appear before the Hon'ble Court of Sessions, as and when directed by that court.
5. The records and the properties involved in the case shall be submitted to the Hon'ble Court of Sessions forthwith, under Section 232(c) of the Bharathiya Nagarik Suraksha Sanhita ,2023.
6. Notify the commitment of the case to the Learned Public Prosecutor Alappuzha, under Section 232(d) of Bharathiya Nagarik Suraksha Sanhita, 2023.
