This case coming on this day, the court passed the following :

**ORDER**

1. The final report is filed by the Sub Inspector of police, Ambalapuzha Police Station in Crime No.1238/2020, alleging commission of offences punishable u/s.324 of Indian Penal Code (in short 'IPC') against the accused.
2. The prosecution case, in brief, is that, due to animosity, on 08.10.2020 at 04:00 PM near Kopparakkadavu-Kattakuzhy road junction, the accused voluntarily caused hurt to CW2 by beating him with a wooden stick on his left shoulder and back. Thus, the accused is alleged to have committed the aforesaid offences.

3. The case was originally taken on file as CC No.819/2020 against accused. On perusal it was noticed that the injured suffers from Down Syndrome. Since the offences under the Right of Persons with Disability Act are to be incorporated, the case was refiled as CP No.08/2026, i.e., present case.
4. Accused appeared before the court and had taken bail. Copy of all the relevant prosecution records were furnished to the accused.
5. On perusal of the prosecution records, this court is satisfied that the offence alleged is exclusively triable by the Hon'ble Sessions Court. Hence, the case is committed to the Hon'ble Sessions Court, Alappuzha as provided u/s.362 of Bharatiya Nagarik Suraksha Sanhita, 2023.
6. The accused shall appear before the Hon'ble Sessions Court, Alappuzha as and when directed.
7. The entire case records and material objects shall be forwarded to the Hon'ble Sessions Court, Alappuzha forthwith. The office is directed to communicate to the learned Public Prosecutor, Alappuzha as provided u/s.362 of BNSS, 2023.
