This petition having been heard on 18.11.2025 and the Court on the same day passed the following:-

ORDER

This is an application filed by the defendant to call for the records of this Court in OS 441/2014. It is claimed that the plaintiff's counsel had

cross examined the defendant and produced a copy of the plaint in that suit. The defendant asserts that the records must be called for to understand the ground realities. It is argued that it would take time to apply and produce the copies from the Court.

2. Heard. Perused the records.

3. This Suit has been filed seeking an injunction to prevent the obstruction of the plaintiff's use of the C schedule pathway. The Respondent/Plaintiff has subsequently filed IA 9/2025 along with a certified copy of the decree in OS 441/2014 dated 12.06.2017, which indicates that the suit was dismissed for default. The petitioner/defendant is also entitled to apply for certified copies of the same and present them, if necessary. Therefore, this petition lacks merit. IA is dismissed. No costs.
