ORDER

Heard the counsel for the plaintiffs/petitioners. No caveat is reportedly pending. Perused the records. The accompanying affidavit discloses a prima facie case. I am satisfied that if the notice is issued before granting the injunction, the resultant delay would defeat the purpose of granting the injunction. Further I believe that if injunction is not granted irreparable injury will be caused to the plaintiffs/petitioners.

Hence, the defendants and any one acting under them are restrained from interfering in the smooth administration of the plaintiff branch, trespassing into the auditorium under the control of the plaintiff branch and also from threatening the plaintiffs by any means until further orders.
