ORDER

This case was charge sheeted by the Inspector of police, Arthunkal Police station , in crime No.49 of 2022 for the offences punishable u/ss. 341,323 of IPC

2. The prosecution allegation, in brief, is that on 16.05.2022 at about 05.00 p.m. the accused uttered abusive words to CW1 at Cherthala South Panchayath, Ward No. 10, on Kanichikulangara-Madakkal Road near Arepparambu Junction. The accused caught hold of CW1's neck, pushed him, and caused pain to his neck and hand, thereby committed the offences punishable under Sections 323 and 341 of the

IPC.

3. Originally, this case was taken on file as C.C. No. 163 of 2022. The Investigating Officer filed the final report, and upon issuance of summons, the accused entered appearance and was released on bail. He was represented by a lawyer of his choice, and copies of all documents produced and relied upon by the prosecution were duly furnished to him. Charge was framed and summons issued to CW1. There after, on perusal of the records, it is seen that CW1 is a minor against whom the alleged criminal act was committed. Since CW1 is a minor, the matter is triable by the Children's Court. Accordingly, this case has been refiled as C.P. No. 19 of 2026 and is committed to the Children's Court, Alappuzha, for trial.

4. Transmit the case records and properties if any, to the Hon'ble Children's Court, Alappuzha. Accused is on bail. He is directed to appear before the Hon'ble Children's Court, Alappuzha as and when required. Issue notice to the Public Prosecutor, Alappuzha.
