## Alappuzha u/s. 232 of BNSS

This case coming on for hearing on this day and the court on the same day passed the following:

**ORDER**

This case was charge sheeted by the Police Sub Inspector, Aroor Police Station in crime No. 906 of 2024 for the offences punishable U/ss. 126(2), 115(2), 118(1), 110 & 3(5) of the Bharatiya Nyaya Sanhita, 2023.

2. The prosecution allegation, in brief, is as follows:- On 02.09.2024 at about 07:30 P.M .,due to animosity towards CW1, the first accused unlawfully restrained the him and beat on his shoulder and 2 to 4 accused persons beat on his hand, 3 rd accused hit Sharon, CW1's relative, with a helmet and he sustained deep injury on his hand. 1 st accused obstructed CW1 and 2 nd accused hit with a knife on his left shoulder and he sustained injury on the left hand muscle portion and below the chest. If CW1 had not evaded the attack, it would have been proved fatal to him. Thereby the accused had committed the offences punishable under Sections, 126(2), 115(2), 118(1), 110 & 3(5) of the Bharatiya Nyaya Sanhita, 2023.

3. The first and second accused were arrested and produced before the court 4.9.2024 and they were remanded. Thereafter they were released on bail granted by this court on 11.09.2024. The third accused was arrested and produced before the court on 5.9.2024 and he was remanded . Thereafter he was released on bail granted by this court on 13.09.2024, and the fourth accused was released on bail as per the order of the hon'ble High Court of Kerala in Bail Appl No 8329/2024 dated 26.11.2024

.Upon filing final report, summons issued to the accused, who entered appearance. They are represented by counsel appointed by them. Copies of the prosecution records were duly furnished to the accused.

4. On a perusal of records, it appear that the offence u/s 110 of BNS alleged against the accused is exclusively triable by the Court of Session. Hence, the case is committed to the Hon'ble Court of Session, Alappuzha u/s. 232 of BNSS for trial.

5. Transmit the case records and properties if any, to the Hon'ble Sessions Court, Alappuzha. Accused are on bail. They are directed to appear before the Hon'ble Sessions Court, Alappuzha as and when required. Issue notice to the Public Prosecutor, Alappuzha regarding the factum of committal of the case.
