Charge : Offence punishable under section 296(b),
115(2), 118(1) and 351(2) r/w 3(5) of
BNS and Sec. 92(b) of The Rights of
Persons with Disabilities Act.

O R D E R : Case against the accused is committed to
the Hon'ble Court of Session, Alappuzha
under section 232 (a) of BNSS.

Heard, perused the records and passed the following :-

O R D E R

1. This case arose from a Final Report filed by the Sub Inspector of Police, Kurathikadu Police Station in Crime No.810/2025 alleging that the accused committed offences punishable u/ss. 296(b), 115(2), 118(1) and 351(2) r/w 3(5) of BNS and Sec. 92(b) of The Rights of Persons with Disabilities Act.

2. The Prosecution case is that, the accused no.1 and 2 in furtherance of their common intention to dishonor and outrage the modesty of CW1, a disabled person on 02.11.2025 at about 10.00 am, beat her with a petiole on her left hand and neck, causing pain, on a public road near Chooralloor Muri in Thekkekkara Village. The accused persons dragged CW1 by holding her hair and also pulled her down. Thus the accused are alleged to have committed the aforesaid offences.

3. On appearance of accused person, copies of relevant prosecution records were given to them. They were released on bail.

4. After perusing the prosecution records and hearing both sides it appears that offences alleged against the accused are exclusively triable by the Hon'ble Court of Session and hence case against the accused is committed to the Hon'ble Court of Session u/s 232(a) of BNSS.

5. Send the entire case records to the Hon'ble Sessions Court, Alappuzha as provided u/s. 232(c) of BNSS.

6. The commitment of the case is being notified to the Public Prosecutor, Alappuzha as provided u/s. 232(d) of BNSS.

7. The accused are directed to appear before the Hon'ble Sessions Court, Alappuzha as and when required by the Hon'ble Court.

8. The material objects, if any, shall be sent forthwith. Office is directed to sent the case records to the Hon'ble Sessions Court, forthwith.
