COMMITMENT ORDER

Accused above named have been sent up to face trial for the alleged commission of offence under Sections 287, 309(5), 312, 351(2) & 3(5) of Bharatiya Nyaya Sanhita, 2023 (hereinafter referred to as the BNS) and under Section 25, 27 and 29 of Arms Act, 1959 by the SHO of Police Station, Ateli.

2. Brief facts of the case of the prosecution are that on 04.07.2025, PSI Rakesh Kumar along-with HC Pardeep Kumar and HC Surender in Government vehicle bearing registration No.HR-35GV-6523 with driver HGH Ravinder Kumar in connection with patrolling duty was present at village Khodma. There he received information from Police Control Room, Narnaul to the effect that in the tile factory of Kajodmal at village Balaha Kalan, three-four young boys have fired shots. On this information, PSI Rakesh Kumar along-with fellow police officials in Government vehicle reached the tile factory of Kajodmal at village Balaha Kalan, where he found empty cartridge on the road and near the gate of the factory and scene of crime team was called at the spot. Scene of crime team inspected the place of occurrence and in the presence of team of scene of crime, a total of six cartridges were recovered out of which five were embossed with 8MM KF and one with 7.65KF. The same were sealed in separate pulandas and stamp of 'PK' was affixed on both the pulandas and same were taken into police possession. At the spot, complainant Rishabh s/o Santosh Kumar, resident of village Balaha Kalan

made one written complaint to PSI Rakesh Kumar to the effect that he is having tile and stone factory in the name of his grandfather Kajodmal Vijay Kumar at village Balaha adjacent to his residential house. Today i.e. 04.07.2025 at about 06:30 P.M. three young boys entered in his factory from gate no.2 of the factory and asked Munim Sandeep s/o Mahavir to show tiles to them. After seeing the tiles, they showed pistol to Munim Sandeep and checked the cash box (*galla*) but no money was found in the cash box. Thereafter, two boys having pistol and country made gun in their hand approached him and asked him where was the owner Kajodmal, then he replied that he had gone to his house, thereafter the abovesaid young boys shot 5-6 fire on the gate of the factory, out of which one bullet hit the mirror of his balcony. Third boy was having plastic bag in his hand and he was providing the bullets to the boys who were firing, while leaving the spot, one of the boy asked to close the factory. One other boy was accompanying the abovesaid three boys, who came with them by driving a car, who stopped the car on the road and was sitting on the driver seat. Further, the abovesaid car was Swift Dzire bearing temporary number, out of the abovesaid boys, two of them were wearing black colour t-shirt, one of them was wearing brown colour t-shirt. The abovesaid boys entered his shop and factory and fired shots with the intention to rob the shop and his factory. Thereafter, the abovesaid boys fled away in the Swife Dzire car towards Singhana. After the occurrence, his cousin namely Parth s/o Vijay Kumar dialed 112 from his mobile

No.8950935453 and the incident is recorded in CCTV camera. On the basis of above facts, it is requested that necessary action may kindly be taken against the abovesaid young boys.

3. On the basis of this complaint, an FIR for the commission of offence under Sections 287, 309(5), 312, 351(2), 3(5) BNS and 25, 27 and 29 of Arms Act was registered. Investigation of the case was conducted by PSI Rakesh Kumar. Statements of witnesses were recorded. During investigation, accused persons were arrested. On completion of investigation, final report under Section 193 BNSS for the commission of offence under Sections 287, 309(5), 312, 351(2), 3(5) BNS and 25, 27 and 29 of Arms Act was presented before the Court against accused persons.

4. Copy of challan was supplied to the accused persons as mandatory requirement under Section 230 BNSS, free of cost.

5. From the perusal of the police report, it is *prima facie* made out that the accused persons have committed offence under Sections 287, 309(5), 312, 351(2), 3(5) BNS and 25, 27 and 29 of Arms Act. Since the offence punishable under Section **312 BNS** is exclusively triable by the Court of Sessions, therefore, the case is committed to the Court of Learned Sessions Judge, Narnaul for **05.08.2026**. The commitment order has been dictated in the presence of learned APP for the State, who has been notified about the commitment of the case. Ld. Asst. Public Prosecutor is directed to inform the Ld. Public Prosecutor of the Learned Sessions Judge, accordingly. Reader is directed to prepare necessary

calandera. Ahlmad is directed to send the case file complete in all respect to the Court of Learned Sessions Judge, Narnaul, well within time.

Till then, accused Vinit @ Sikander, Karambir @ Karma and Ankit be kept in judicial custody and are directed to be produced before the said Court on the date fixed through V.C. Accused on bail are also directed to remain present before the Court of Learned Sessions Judge, Narnaul on the date fixed at 10:00 A.M. sharp.
