This petition coming on this day for consideration, the court passed the following:-

ORDER

1. This petition is filed by the accused no.8 in CC.94/2022 for seeking permission to renew passport.
2. The petitioner is the accused in the above crime alleging offences under sections 143, 147, 148, 341, 323, and 324 r/w 149 IPC.
3. According to the petitioner, he is innocent and falsely implicated in this case. He stated that he is a holder of passport bearing No.K5082827. Now he intends to renew his passport and seeks for permission to renew his passport. According to the petitioner he filed CMP.6110/2023 for renew his passport and permission to renew passport for 1 year is granted as per order dated 02.12.2023. He intends to go to Maldives for a job for his livelihood. It is informed that validity of passport for at least 2 years is necessary for issuing visa. He produced order of the Hon'ble High Court of Kerala in CrI.MC.No.1381/2025 dated

18.02.2025 permitting the petitioner to approach the trial court seeking revalidation of his passport for further period and directing the court below to pass appropriate orders thereon, taking into account the present stage of the case and in accordance with the directions in Thadevoose Sebastial v.Regional Passport Officer [2021(5)KLT 531]. He produced copy of passport before the court.

4. Copy served to the learned APP. No objection seen filed.

5. Heard both sides and perused the records.

6. Final report is already filed and trial is in progress. The case is of the year 2022. Now charge was framed, read over and explained to the accused. There are eight witnesses are to be examined for the completion of the trial. Considering all these aspects, this court has no objection in renewing the passport. Therefore permission to renew passport for 2 years is granted on the following terms:-

- (1) The petitioner/accused shall not leave the country without prior permission from the court.
- (2) He shall file an affidavit that he will return within this period and stating his address in the country where he is intending to go.
- (3) Petitioner shall appear before this court as and when demanded.
