**Offence : U/Sec 143,147,149,283,117(e) of IPC **

Plea : Guilty

Findings : Guilty

JUDGMENT

1. This case is instituted upon the final report submitted by the State of Kerala (Police) alleging commission of offence punishable U/Sec **143,147,283 R/W149** of **IPC AND 117(e)** of Kerala Police Act .

2. The A25 is absent. Accused pleaded guilty through counsel to the charge framed for the above said offence. I am satisfied that the plea is made voluntary. Hence the plea of the Accused is accepted. Having regard to the facts and circumstances of the case, I am satisfied that the following sentence shall meet the ends of the justice.

In the result, the Accused A25 convicted for the offence punishable under Section 143,147,149,283,117(e) of the IPC \ and Accused is sentenced to pay a fine of Rs.2000/-. In case of the default of the Accused A25 in paying the said fine amount, Accused shall undergo simple imprisonment for 10 Days.
