**Offence : U/Sec 143,147,149,283 of IPC **

U/Sec 117(e) of Police Act, 1960 (Kerala)

Plea : Guilty

Findings : Guilty

JUDGMENT

1. This case is instituted upon the final report submitted by the State of Kerala alleging commission of offence punishable U/Sec **143,147,149,283** of **IPC ** , U/Sec **117(e)** of **Police Act, 1960 (Kerala)** .

2. The A43 is present. The particulars of the above said offence are read over and explained to the Accused to which Accused pleaded guilty. I am satisfied that the plea is made voluntary. Hence the plea of the Accused is accepted. Having regard to the facts and circumstances of the case, I am satisfied that the following sentence shall meet the ends of the justice.

3. The A53, A63, A56,A117 are absent. Accused pleaded guilty through counsel to the charge framed for the above said offence. I am satisfied that the plea is made voluntary. Hence the plea of the Accused is accepted. Having regard to the facts and circumstances of the case, I am satisfied that the following sentence shall meet the ends of the justice.

In the result, the Accused A43 A53, A63, A56,A117 convicted for the offence punishable under Section 143,147,149,283 of the IPC \ and Accused is sentenced to pay a fine of Rs.500/- each. In case of the default of the Accused A43 A53, A63, A56,A117 in paying the said fine amount, Accused shall undergo simple imprisonment for 10 Days. The Accused A43 A53, A63, A56,A117 are further convicted for the offence punishable under Section 117(e) of the Police Act, 1960 (Kerala) and Accused is sentenced to pay a fine of Rs.500/- each. In case of the default of the Accused A43 A53, A63, A56,A117 in paying the said fine amount, Accused shall undergo simple imprisonment for 10 Days.

Case against other accused are refiled with Registration No:CC 568/2025.
