the following:-

**ORDER**

This is a case arose on a final report submitted by the  
Excise Inspector, Nooranadu Range in Cr. No.89/2025 alleging  
commission of offences punishable u/s.55(i) of Abkari Act I of  
1077.

2. Prosecution case in brief is that, on 27.08.2025 at 05.45  
p.m., the accused was found in possession of 800 ml of Indian  
Made Foreign Liquor and engaged in the sale of the same, on  
the north side of the Kottackattusery-Panayil road, opposite to  
Koippally pond in Panayil Muri in Palamel Village. Since the  
accused ran away he could not be arrested. The Excise Inspector  
registered the crime and contraband were seized. Therefore, the

accused is liable for the commission of offence punishable u/s 55(i) of Abkari Act.

3. Upon taking cognizance, the case was taken on file. The accused surrendered before the court on 13.03.2026 and was released on bail. Copies of all relevant prosecution records were furnished to him.

5. After perusing the prosecution records, it appears that the offence alleged against the accused is exclusively triable by a Court of Session, and hence the case against the accused is committed to the Hon'ble Court of Sessions, Alappuzha, as per section 232 (a) of Bharatiya Nagarik Suraksha Sanhita (BNSS), 2023.

6. The case records shall be forwarded to the Hon'ble Sessions Court, Alappuzha and the property produced if any, shall be send subject to Rule 77(2) of the Criminal Rules of Practice, Kerala, as and when called for.

7. Notify the committal of the case to the learned Public Prosecutor, Alappuzha, as per section 232 (d) of BNSS.
