JUDGMENT

1. This case is instituted upon the final report submitted by the State of Kerala (Police) alleging commission of offence punishable U/Sec 189(2), 191(2), 285, 296(b) of Bharatiya Nyaya Sanhita .

2. The A1,A2,A3,A4,A5,A6,A7,A8,A9,A10 is absent. Accused pleaded guilty through counsel to the charge framed for the above said offence. I am satisfied that the plea is

made voluntary. Hence the plea of the Accused is accepted. Having regard to the facts and circumstances of the case, I am satisfied that the following sentence shall meet the ends of the justice.

In the result, the Accused A1, A2, A3, A4, A5, A6, A7, A8, A9, A10 convicted for the offence punishable under Section 189(2), 191(2), 285, 296(b) of the Bharatiya Nyaya Sanhita and Accused is sentenced to pay a fine of Rs.500/-. In case of the default of the Accused A1, A2, A3, A4, A5, A6, A7, A8, A9, A10 in paying the said fine amount, Accused shall undergo simple imprisonment for 10 Days.

The properties produced in this case, if any, shall be disposed of as per law.
